Re: Vernon Asher Drain, 111th Street and Pennsylvania Street Intersection Improvements

Attached are petition, plans, and other information for the proposed reconstruction of the Vernon Asher Drain, for the 111th Street and Pennsylvania Street Intersection Improvements. The reconstruction was petitioned by the City of Carmel. During the road intersection improvements, the Vernon Asher Drain, PIA Hospital Relocation Arm will be affected and those changes are as follows:

PIA Hospital Relocation Arm

The project will reconstruct a portion of enclosed storm sewer system which is part of the PIA Hospital Relocation Arm. A new manhole, proposed structure 66, will be set approximately 35 feet east of existing structure 109, per the construction plans for PIA Hospital, designed by Schneider Engineering, having job number 717. The new drain will be 24 feet of 36" RCP to Str. 64, then 51 feet of 36" RCP to a new structure 15 feet south of existing Str. 109 on the original drain. Also to be removed is 35 feet of 15" RCP from Str. 111 to Str. 110 of the PIA Hospital Plans and the end section that is Str. 111. This is as shown on sheet 18 of the Roundabout Construction Plans for 111th Street & Pennsylvania Street by A&F Engineering, having project number 1297165.

Also previously removed with the Pennsylvania Street project in 2000 was Str. 108 to Str. 107 and Str. 106 to Str. 105 of the PIA Hospital Relocation Arm. This is 55 feet of 12" RCP and 50 feet of 12" RCP, respectively.

The total length of new drain shall be 75 feet. The 190 feet of original drain from Str. 111 to 110, Str. 108 to 107, Str. 106 to 105, approximately 35 feet east of Str. 109 to Str. 109, and Str. 109 to approximately 15 feet south of Str. 109 shall be vacated. This proposal will remove 115 feet from the Vernon Asher total length.

The cost of the reconstruction is to be paid by the City of Carmel.


Since the petitioner is the City of Carmel and is being performed under public bid process, no bond is required for the relocation/reconstruction work.

The easement for this drain shall remain the existing easement under the non-enforcement request approved by the Drainage Board on October 16, 1989 and recorded in the Office of the Hamilton County Recorder as instrument number 8923351 or the new right of way line for the street intersection improvements, whichever is greater. Work will be completed in the easement on the following parcels:

PETITION FOR RELOCATION AND RECONSTRUCTION

The City of Carmel City Engineer's Office (hereinafter "Petitioner"),
hereby petitions the Hamilton County Drainage Board for authority to relocate and improve a
section of the Vernon Asher Drain, and in support of
said petition advises the Board that:

1. Petitioner owns real estate through which a portion of the Vernon Asher Drain runs.
2. Petitioner plans to develop its real estate with roads, buildings, utilities, storm drains, sanitary sewers and other structures.
3. Petitioner's proposed development of its real estate will require relocation and reconstruction of a portion of the Vernon Asher Drain, as specifically shown on engineering plans and specifications filed with the Hamilton County Surveyor.
4. The work necessary for the proposed relocation and reconstruction will be undertaken at the sole expense of the Petitioner and such work will result in substantial improvement to the Vernon Asher Drain, without cost to other property owners on the watershed of the Vernon Asher Drain.

WHEREFORE, Petitioner requests that an Order issued from the Hamilton County Drainage Board authorizing relocation and reconstruction of the Vernon Asher Drain, in conformance with applicable law and plans and specifications on file with the Hamilton County Surveyor.

109 to approximately 15 feet south of Structure 109**


On this 22nd day of April, 2013, the Hamilton County Drainage Board has held a hearing on the Maintenance Report and Schedule of Assessments of the **Vernon Asher Drain, 111th Street and Pennsylvania Street Intersection Improvements, Structure 111 to 110, Structure 108 to 107, Structure 106 to 105, approximately 35 feet east of Structure 109 to Structure 109 and Structure 109 to approximately 15 feet south of Structure 109.**

Evidence has been heard. Objections were presented and considered. The Board then adopted an order of action. The Board now finds that the costs of continued maintenance to the portion of the above drain exceed the benefits to the real estate benefited by the portion of the drain to be abandoned and issues this order vacating the above section of the **Vernon Asher Drain, 111th Street and Pennsylvania Street Intersection Improvements, Structure 111 to 110, Structure 108 to 107, Structure 106 to 105, approximately 35 feet east of Structure 109 to Structure 109 and Structure 109 to approximately 15 feet south of Structure 109.**



FINDINGS AND ORDER FOR RECONSTRUCTION

The matter of the proposed Reconstruction of the **Vernon Asher Drain, 111th Street and Pennsylvania Street Intersection Improvements** came before the Hamilton County Drainage Board for hearing **on April 22, 2013**, on the Reconstruction Report consisting of the report and the Schedule of Damages and Assessments. The Board also received and considered the written objection of an owner of certain lands affected by the proposed Reconstruction, said owner being:

Evidence was heard on the Reconstruction Report and on the aforementioned objections.

The Board, having considered the evidence and objections, and, upon motion duly made, seconded and unanimously carried, did find and determine that the costs, damages and expenses of the proposed Reconstruction will be less than the benefits accruing to the owners of all land benefited by the Reconstruction.


The Board having considered the evidence and objections, upon motion duly made, seconded and unanimously carried, did adopt the Schedule of Assessments as proposed, subject to amendment after inspection of the subject drain as it relates to the lands of any owners which may have been erroneously included or omitted from the Schedule of Assessments.

The Board further finds that it has jurisdiction of these proceedings and that all required notices have been duly given or published as required by law.


Wherefore, it is ORDERED, that the proposed Reconstruction of the **Vernon Asher Drain, 111th Street and Pennsylvania Street Intersection Improvements** be and is hereby declared established.

Thereafter, the Board made inspection for the purpose of determining whether or not the lands of any owners had been erroneously included or excluded from the Schedule of Assessments. The Board finds on the basis of the reports and findings at this hearing as follows:
