Re: O.F. Beeson Drain, Crooked Creek Gun Club Extension

Attached is a drain map and petition for the O.F. Beeson Drain, Crooked Creek Gun Club Extension. This proposed drain is located in Section 35, Township 20 North, Range 5 East in White River Township, Hamilton County.

I have made a personal inspection of the land described below. Upon doing so, I believe the drain is practicable, will improve the public health, benefit a public highway, be of public utility and that the costs, damages and expenses of the proposed drain will probably be less than the benefits accruing to the owners of land likely to be benefited.

This extension shall consist of approximately 1528 feet of open drain beginning at the intersection of the existing drain at the east property line of parcel #07-03-35-00-00-002.000, said intersection being approximately 830 feet south of 246th Street, thence following the existing open ditch, Bear Creek, to the confluence with Duck Creek, said confluence being approximately 250 feet west and 730 feet north of the Southeast Corner of the Northwest Quarter of Section 35, Township 20 North, Range 5 East.

The nature of maintenance work required is as follows:

- Bank erosion protection and/or seeding as might be required;
- Removal of debris and/or blockages from the drain;
- Removal of Beaver Dams;
- Any other repairs necessary to restore proper flow to the open ditch.

The frequency with which maintenance work should be performed is annually as required by the condition of the drain.


The easements for the drain should be set at 75 feet from top of bank as set out in IC 36-9-27-33. According to the FEMA Flood Insurance Rate Maps Number 18057C0070F, dated February 19, 2003 this area is covered by floodplain for Duck and Bear Creeks. Therefore, I believe that no damages will result to landowners by the regulating of this drain.

Drainage easement will be added to the following tracts:


The Board having considered the evidence and objections, upon motion duly made, seconded and unanimously carried, did adopt the Schedule of Assessments as proposed, subject to amendment after inspection of the subject drain as it relates to the lands of any owners which may have been erroneously included or omitted from the Schedule of Assessments.

The Board further finds that it has jurisdiction of these proceedings and that all required notices have been duly given or published as required by law.




