Re: Cool Creek Drain, Cool Creek Park Extension

Attached is a drain map for the extension of the Cool Creek Drain. This proposed drain is located in Washington Township.

I have made a personal inspection of the land described below. Upon doing so, I believe that the drain is practicable, will improve the public health, benefit a public highway and be of public utility and that the costs, damages and expenses of the proposed drain will probably be less than the benefits accruing to the owners of land likely to be benefited. The drain will consist of the following two arms:

Cool Creek Drain – Cool Creek Park Arm

Cool Creek Drain – Cool Creek Park West Arm

Open Ditch

2,640 ft.

The total length of the drain will be 3,730 feet.

The Cool Creek Park Arm will begin at the east property line of Tract 09-10-18-00-00-001.000, owned by Hamilton County Park & Recreation Board. The extension will follow the existing open ditch upstream to the south property line of 09-10-18-00-005.001 owned by Herbert Sweet.

The Cool Creek Park West Arm will begin at the confluence with the Cool Creek Park Arm on Tract 09-10-18-00-00-001.000, owned by Hamilton County Park & Recreation Board. The extension will follow the existing open ditch upstream to the west right of way line of Westfield Boulevard, which is also the east property line of Tract 09-09-13-00-00-007.001, owned by Robert D. and Lynn Habig.

The nature of maintenance work required is as follows:

1. Bank erosion protection and/or seeding as might be required:

- 2. Removal of debris and/or blockages from existing open drain;
- 3. Removal of beaver dams;
- 4. Any other repairs necessary to restore proper flow to the open ditch.

The frequency with which maintenance work should be performed is annually as required by the condition of the drain.

The easements for the drain should be set at 75' from top of bank as set out in IC 36-9-27-33. Additional drainage easement will be added to the following tracts:

Upon reviewing the flood mapping for this area it appears that the area to be easement lies partially within the floodplain. This is shown on the FEMA FIRM for the area, Map Number 18057C0119F and 18057C0138F, dated February 19, 2003. Therefore, damages shall be set at \$0.00.

I believe this proposed drain meets the requirements for Urban Drain Classification as set out in IC 36-9-27-67 to 69. Therefore, this drain shall be designated as an Urban Drain.

I recommend that the Board set a hearing for this proposal for May 27, 2008.
