RE: Wheeler & Beals, Cool Creek Drain

On January 24, 2005 and February 28, 2005 the Board held hearings to establish the Wheeler & Beals Drain maintenance assessments. These hearings were for the Wheeler & Beals Drain Extension (See Surveyor's Report dated December 21, 2004) Wheeler & Beals Drain, Bainbridge Arm (Surveyor's Report dated December 21, 2004) and Wheeler & Beals Drain, Custom Commerce Park Arm (Surveyor's Report dated January 4, 2005).

At present the Wheeler & Beals Drain maintenance assessment affects 112.83 acres and 18 lots. In order to consolidate this drain with both existing drains and future drains within the Cool Creek Drainage Shed and since the Wheeler & Beals Drain is a sub-shed to the overall Cool Creek drainage shed. I recommend to the Board that the name of the drain be changed from Wheeler & Beals Drain to Cool Creek Drain.

I recommend that the Board set a hearing for this name change for October 24, 2005.
