Re: E. M. Osborne Arm, Anna Kendall Drain

Attached are petitions, non-enforcements and plans for the proposed relocation of the E. M. Osborne Drain through Oak Ridge Industrial Park, Pine Ridge Section 3, Quail Ridge Section 3 and Quail Ridge Section 4. The two relocations are being proposed by Westfield Investment Company LP. The proposal is to vacate portions of the existing E. M. Osborne Drain through these sections and relocate the drain per the enclosed plans.

The first phase of the request is for the Oak Ridge Industrial Park, Pine Ridge Section 3 and Quail Ridge Section 3 Subdivisions. The new footage for this portion is as follows:

The new location of the regulated drain through Oak Ridge Industrial Park, Pine Ridge Section 3 and Quail Ridge Section 3 is between structures 15, 14, 13, 12, 11, 10, 9, 8, 6, 5, 4, 3, MES 13 and MES 2. The open drain is the portion from MES 13 and 2 to its confluence with the Anna Kendall Drain. The proposed relocation is shown on plans prepared by Weihe Engineers dated March 6, 1997 (Job #92-902) sheets 2, 3, 4. The portion of open drain can be found on plans by Weihe Engineers February 6, 1997, sheet 2.

The total length on new drain for these sections shall be 4,103 feet. The 2,689 feet of original E. M. Osborne Drain between stations 72+34 and 99+53 shall be vacated with this proposal. This proposal will add 1,484 feet to the drains total length.

I recommend the Board approve the attached non-enforcement submitted with the Oak Ridge Industrial Park, Quail Ridge Section 3 and Pine Ridge Section 3 plans.

The second portion of this request concerns the E. M. Osborne Drain through Quail Ridge Section 4 subdivision. The new footage is as follows:

18" RCP 892 ft

The new location of regulated drain in Quail Ridge Section 4 is through the green space (park) between Manholes #1, 2, 3 and 4, as shown on plans prepared by Weihe Engineers, dated April 29, 1998 (sheets 2 and 2A).

The total length of new drain shall be 892 feet. The 710 feet of original E. M. Osborne Drain between stations 47+70 and 54+80 shall be vacated with this proposal. This proposal will add 182 feet to the drain's total length.

The portion of original E. M Osborne Drain across Countryside Section 4 between stations 54+80 and 72+34 was vacated with the relocation of the drain by Platinum Properties (see my report dated May 10, 2000).

The cost of both of the relocations is to be paid by Westfield Investment Company LP.

I believe this proposed drain meets the requirements for Urban Drain Classification as set out in IC 36-9-27-67 to 69. Therefore, this drain shall be designated as an Urban Drain.

I recommend a hearing be set for February 26, 2001.



The length of the drain due to the changes described above is now **4126 feet**. The original tile drain was vacated from Sta 72+34 to Sta 99+53. Therefore, the net length of drain is **1407 feet**.

The second phase mentioned in my report dated January 24, 2001 is for the portion to be relocated through Quail Ridge Sec. 4. During construction, changes were made to the drain, which will alter the plans submitted with my report for this drain. The changes are as follows:

The length of the drain due to the changes described above is now 974 feet. The original tile drain was vacated from Sta 47+70 to 54+80. Therefore, the net length of drain is 264 feet.
