Attached is a petition and plans for the proposed relocation of the Harmon Clark Drain. The relocation is being proposed by WLB Associates, Incorporated, Oakridge Investments LTD and Hinshaw Realty, Incorporated. The proposal is to relocate and reconstruct the Harmon Clark Drain from Sta. 6+50 through Sta. 23+00 of the original description of South Park II.

The open ditch listed above is that which crosses Lot 2 between Str. 717 to the detention facility located in Common Area "A" as shown on the plan for South Park II by Weihe Engineers, Inc. dated August 14, 2002 revised October 2, 2002. The open ditch is also along the west row of the Monon from the northeast corner of South Park II to the detention facility in Common Area "A". It shall also include that portion of open ditch from storm structure #720 to the south property line of South Park II.

The total length of new Drain shall be 3,394 feet. The 1,650 feet of original drain between Sta. 6+50 and Sta. 23+00 shall be vacated. This proposal will add an additional 2,284 feet to the drains total length. 20+50 5834

I believe this proposed drain meets the requirements for Urban Drain Classification as set out in IC 36-9-27-67 to 69. Therefore, this drain shall be designated as an Urban Drain.

The retention lake located in Common Area "A" is to be considered part of the regulated drain. The inlet and outlet will be maintained as part of the regulated drain and the lake is to be considered as open ditch. The maintenance of the lake will not include mowing responsibility of the property owner. The Board will also retain jurisdiction for ensuring the storage volume for which the lake was designed will be retained. Thereby, allowing no fill or easement encroachments.

The subsurface drains (SSD) to be part of the regulated drain are those located under the curbs. Only the main SSD lines which are located within the right-of-way are to be maintained as regulated drain. Laterals for individual lots will not be considered part of the regulated drain.

The cost of the relocation is to be paid by WLB Associates, Inc., Oakridge Investments LTD and Hinshaw Realty, Inc. Because the project is to be paid by the petitioner and is within the boundaries of the petitioners property the project falls under the requirements as set out in IC 36-9-27-52.5. Therefore, a public hearing with 30 day notice is not required for the petition.
