

Attached is a petition, non-enforcement request, plans, calculations, quanity summary and assessment roll for the Springmill Ponds, Section 2 Drain.

I have reviewed the submittals and petition and have found each to be in proper form.

I have made a personal inspection of the land described in the petition. Upon doing so, I believe that the drain is practicable; will improve the public health; benefit a public highway and be of public utility; and that the costs, damages and expenses of the proposed drain will probably be less than the benefits accuring to the owners of land likely to be benefitted. The drain will consist of the following:

6"	SSD	2580ft	21"	RCP	322ft
12"	RCP	382ft	24"	RCP	683ft
15"	RCP	540ft	27"	RCP	1220ft
18"	RCP	544ft	30"	RCP	1288ft

The total length of the drain will be 7559 feet.

Pond 1 in the common area is not to be part of the regulated drain. The inlet and outlet pipes are maintained as regulated drain, but the pond itself is to be maintained by the property owners association.

I have reviewed the plans and believe the drain will benefit each lot equally. Therefore, I recommend each lot be assessed equally. I recommend a maintenance assessment of \$25.00 per lot, \$5.00 per acre for roadways. With this assessment the total annual assessment for the drain/this section will be $\frac{1492}{2}$.

Lots 14 thru 23, 25 and 26 are also to be assessed the reconstruction or construction of the Springmill Crossing or Village Farms Drainage. However, for maintenance purpose, these lots are proposed to be assessed to the Springmill Pon drain only. All lots at some time in the future will be assessed for reconstruction and maintenance of the Osborn-Collins Drain.

I recommend a hearing be set for December 1990. At that time I recommend the non-enforcement request be approved by the Board.



During construction, changes were made to the drain which will alter the plans submitted with my report for this drain dated October 11, 1990. The changes are as follows: Structure 49B- Structure 49C was relocated for Buckhorn Subdivision. Structure 49A -Structure 49B now consists of 30" RCP at 567 feet. Structure 49B - 49C now consists of 16 feet of 36" RCP.

The length of the drain due to the changes described above is now 7567 feet.

The non-enforcement was approved by the Board at its meeting on February 19, 1991.
