Re: Cool Creek Drain, Westfield Business Park Arm - U.S. 31 Reconstruction

Attached are petition, plans, and other information for the proposed reconstruction of the Cool Creek Drain, Westfield Business Park Arm, for the U.S. 31 Road Project. The reconstruction was petitioned by the Indiana Department of Transportation. During the reconstruction of Westfield Park Drive and Sun Park Drive, and Wheeler Connector Road, the Westfield Business Park Arm, Cool Creek Drain will be affected and those changes are as follows:

#### **Westfield Business Park – Section 1 Arm**

The project will reconstruct a portion of Westfield Business Park – Section 1 Arm, with the reconstruction of Westfield Park Road and the new Westfield Business Park Court. The drain to be removed is Str. 8 to Str. 7, then to Str. 101; Str. 6 to Str. 5; then to Str. 100, and Str. 3 to Str. 2, per the Westfield Business Park, Section 1 by Weihe Engineers, Inc., and having job number 87-488. This above mentioned drain being along the current Westfield Business Park Road.

The new drain shall be those lengths of pipe between the following structures: 7444 to 7443, 7443 to 7442, 7442 to 7441, 7443 to 7443A, 7443A to 7434, 7434 to 7433, 7433 to 7445, 7443A to 7433A, 7433A to 7434A, 7434A to 7435, 7435 to 7435A, 7435A to 7446, 7434A to 7436B, 7436B to 7436, 7436 to 7436A, 7430 to 7431, 7431 to 7432, 7432 to existing Str. 100, 7460 to 7461, 7461 to 7462, 7462 to end section, 39 feet of open ditch to Str. 7499, Str. 7499, and 45 feet of open ditch to Str. 7430. This is as shown on sheets 129, 132, and 133 of the U.S. 31 Construction plans, Segment 7, having project number 1296427, contract number IR-34750, and dated September 7, 2012.

The total length of new drain for this arm shall be 1,056 feet. The 98 feet of original drain between the structures listed above shall be vacated. The change in drain length to this arm will be an increase of 958 feet.

#### **Sun Communications Business Park – Section 1 Arm**

The project will reconstruct a portion of Sun Communication Business Park – Section 1 Arm, with the construction of the Wheeler Connector Road. The reconstruction will replace 33

feet of 15" RCP from Str. 708 to Str. 707, per the Sun Communication plans by Paul I. Cripe, Inc., dated March 2, 1989, and having job number 87491-00000, with 30 feet of 12" RCP.

This is from existing Str. 707 to new Str. 7928. Also to be included is 49 feet of 12" RCP from Str. 7458 to Str. 7928 and 76 feet of 12" RCP from Str. 7454 to Str. 7928. This is as shown on sheet 119 of the U.S. 31 Construction plans having project number 1296427, contract number IR-34750, and dated September 7, 2012. The total length of new drain for this arm shall be 155 feet. The 33 feet of original drain between Str. 708 and 707 shall be vacated. The change in drain length to this arm will be an increase of 122 feet.

**Sun Communications Business Park – Section 2 Arm**

The project will remove a portion of Sun Communication Business Park – Section 2 Arm, with the construction of the Sun Park Drive extension. The removal will begin at the riser, Str. R1, on the 6" SSD per the Sun Communication plans by Paul I. Cripe, Inc., dated May 21, 1990, and having job number 87491-20220, and run 139 feet south to the new southern ROW of Sun Park Drive. This is as shown on sheet 135 of the U.S. 31 Construction plans having project number 1296427, contract number IR-34750, and dated September 7, 2012. The total length of vacated drain for Sun Communication Business Park – Section 2 Arm shall be 139 feet.

**Project Summary:**

The total change to the Cool Creek Drain, Westfield Business Park Arm is an increase of 941 feet as a sum of all the changes to the drain.

The cost of the reconstruction is to be paid by the Indiana Department of Transportation.


Since the petitioner is the Indiana Department of Transportation and is being performed under public bid process, no bond is required for the relocation/reconstruction work.

The easement for this drain shall remain the existing statutory 75' from the centerline of the tile or the top of bank of the open ditch, as per IC 36-9-27-33, or the limits of the public road right of ways. This reconstruction of the regulated drain will move or add additional easement and work will be completed in the easement of the following parcels:

The Board further finds that it has jurisdiction of these proceedings and that all required notices have been duly given or published as required by law.



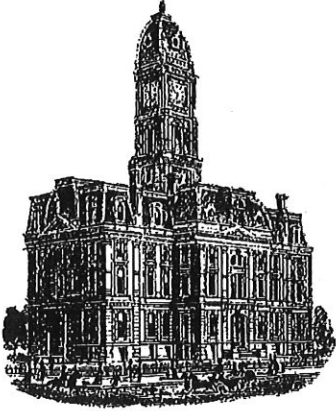

Attached are as-built and other information for Westfield Business Park Sec. 1 – US 31 Reconstruction. An inspection of the drainage facilities for this section has been made and the facilities were found to be complete and acceptable.


During construction, changes were made to the drain, which will alter the plans submitted with my report for this drain-dated February 5, 2015. The report was approved by the Board at the hearing held March 23, 2015. (See Drainage Board Minutes Book 16, Pages 131-132) \*\*It should be noted that this final report covers only the Westfield Business Park Sec. 1 Arm covered in my initial report. A second final report will be written for the Sun Communications Business Park Arm.

The changes to the drain are as follows: The 12" pipe as installed as 202 feet of RCP and 360 feet of HDPE. The 15" pipe was installed as 177 feet of HDPE. The 18" pipe was installed as 215 feet of HDPE. Structure 7444 was set in place of existing structure 2. The pipe between structure 7461 to structure 7462 was omitted. The open ditch was shortened from 84 feet to 79 feet. The length of the drain due to the changes described above is now **1033 feet**. Also, it should be noted that this project removed 98 feet of 15" RCP installed with Westfield Business Park Sec. 1 drain.

The work was completed with existing regulated drain easement and or road right of way. The work was paid for by the Indiana Department of Transportation.

I recommend the Board approve the drain's construction as complete and acceptable.
