Attached is the plan for the extension of the Crooked Creek Drain, English Oaks Arm. The proposal is to extend the drain from the west end of an existing 15" RCP under Shelbourne Road across the new Carmel Fire Station No. 42 site and the House Inv Ham Co Land Fund LP (17-13-06-04-05-001.000) property to an existing CMP culvert pipe under 106th Street. The extension is located within the existing R/W along the north side of 106th Street.

The extension will consist of the following.

12" RCP – 25 feet Open Ditch – 315 feet 15" RCP – 898 feet


The total length of new drain shall be 1238 feet. This proposal will add an additional 1238 feet to the Crooked Creek Drain, English Oaks Arm.

The portion of open ditch listed above is that from the outlet of the existing 15" RCP to the existing 48" CMP culvert pipe under 106th Street. The 15" RCP under Shelbourne Road will not become part of the regulated drain (see Crooked Creek Drain, English Oaks Arm report dated October 18, 2000).

I recommend a hearing be set for November 26, 2001.


The length of the drain due to the changes described above is now 1220 feet.


