Re: Isaac Jones Drain, Hortonville-Chatham Hills Arm

Attached is a petition filed by Henke Development Group, along with non-enforcement requests, plans, calculations, quantity summary and assessment roll for the Hortonville – Chatham Hills Arm, Isaac Jones Drain to be located in Washington Township. I have reviewed the submittals and petition and have found each to be in proper form.

I have made a personal inspection of the land described in the petition. Upon doing so, I believe that the drain is practicable, will improve the public health, benefit a public highway, and be of public utility and that the costs, damages and expenses of the proposed drain will probably be less than the benefits accruing to the owners of land likely to be benefited. The drain will consist of the following:

24" RCP	1,375 ft.	30" RCP	1,031 ft.	
36" RCP	775 ft.	Open Ditch	400 ft.	

The total length of the drain will be 3,581 feet.

The lengths of storm sewer to be included as regulated drain are shown on the attached plans for Chatham Hills Section II by American Structurepoint on sheets C301, C302, and C305. Those lengths are from Str. 2606 to Str. 2605, then 2604B, 2604A, 2604, 2602, and 2601. Also from Str. 2011 to Str. 2010, then 2009, 2008, 2007, 2006, and ending at 2005. Also from Str. 2090 to Str. 2089, then 2088, 2087, 2083, 2082, 2081 and ending at 2080. The final leg from Str. 2087 to Str. 2086. The 400 feet of open ditch listed above is from Str. 2011 to Str. 2601 and from Str. 2090 to Str. 2601 through Pond #2000.

The retention ponds (Pond #2000) located in Common Area Block #9 is not to be considered part of the regulated drain. Pond maintenance assumed by the Drainage Board shall only include the inlets and outlet as part of the regulated drain. The maintenance of the retention ponds (lakes) such as sediment removal and erosion control along the banks, mowing and aquatic vegetation maintenance and control will be the responsibility of the property owner or Homeowners Association. The Board will also retain jurisdiction for ensuring the storage volume for which the pond was designed will be retained. Thereby, allowing no fill or easement encroachments.

This project is a cost share project between the Hamilton County Drainage Board and Henke Development Group, per an agreement discussed by the Board at a meeting on March 14, 2016 (Hamilton County Drainage Board Minutes Book 16, pages 469-471). The Drainage Board cost share is for installation of the pipe lengths listed below and upsizing of a pipe needed for the development but required to be a large size to accommodate the flow through, also included in the footage below.

Per the agreement approved on May 26, 2016, the footages paid by the Board for upsizing and new pipe are from Str. 2090 to Str. 2089, then 2088, 2087, 2083, 2082, 2081, and ending at Str. 2080

Since this is a cost share project with the Drainage Board and that money will not be released until the work is complete, the required bonding for this project is being waived. The installation, inspection, and recorded drawing should be completed before the cost share money is released to Henke Development Group per the agreement with the Drainage Board.

I believe this proposed drain meets the requirements for Urban Drain Classification as set out in IC 36-9-27-67 to 69. Therefore, this drain shall be designated as an Urban Drain.

I recommend that upon approval of the above proposed drain that the Board also approve the attached non-enforcement requests. The request will be for the reduction of the regulated drain easement to those easement widths as shown on the secondary plats for Chatham Hills Section 2A and Chatham Hills Section 2B as recorded in the office of the Hamilton County Recorder.

I recommend the Board set a hearing for this proposed drain for July 25, 2016.

Petitioner is the owner of all lots in the land affected by the proposed new regulated drain. The drainage will affect various lots in <u>Chatham Hills Section II</u>, a subdivision in Hamilton County, Indiana. The general route of such drainage shall be in existing easements and along public roads as shown in the plans on file in the Surveyor's Office.

Petitioner believes that the cost, damages and expenses of the proposed improvement will be less than the benefits which will result to the owners of the land likely to be benefited thereby. Petitioner believes the proposed improvements will:

- (a) improve public health
- (b) benefit a public street
- (c) be of public utility

Petitioner agrees to pay the cost of construction of the drainage system and requests periodic maintenance assessments by the Board thereafter.

The Petitioner also agrees to the following:

- 1. To provide the Drainage Board a Performance Bond or Non-Revocable Letter of Credit for the portion of the drainage system which will be made a regulated drain. The bond will be in the amount of 120% of the Engineer's estimate. The bond will be in effect until construction of 100% of the system is completed and so certified by the Engineer.
- The Petitioner shall retain an Engineer throughout the construction phase. At completion of the project the Petitioner's Engineer shall certify that the drainage system which is to be maintained as a regulated drain has been constructed as per construction plans.
- 3. The Petitioner agrees to request in writing to the County Surveyor any changes from the approved plan and must receive written authorization from the County Surveyor prior to implementation of the change. All changes shall be documented and given to the Surveyor to be placed in the Drain file.
- 4. The Petitioner shall instruct his Engineer to provide a reproducible print on a 24" x 36" Mylar of the final design of the Drainage System. This shall be submitted to the County Surveyor prior to the release of the Performance Bond.
- 5. The Petitioner shall comply with the Erosion Control Plan as specified on the construction plans. Failure to comply with the Erosion Control Plan shall be determined by the Board as being an obstruction to the drainage system. The County Surveyor shall immediately install or repair the needed measures at Petitioners cost as per IC 36-9-27-46.

MEMORANDUM OF UNDERSTANDING BETWEEN THE HAMILTON COUNTY DRAINAGE BOARD, ("the Drainage Board"), AND CHATHAM HILLS, LLP, ("the Developer"), CONCERNING THE CONSTRUCTION OF DRAINAGE IMPROVEMENTS

WITNESS THAT:

WHEREAS, the Developer plans to construct infrastructure for the Chatham Hills residential development and golf course, in the northern part of Washington Township, Hamilton County, Indiana; and,

WHEREAS, the Drainage Board has jurisdiction over certain regulated drains within Hamilton County; and,

WHEREAS, the Developer has offered to upsize the part of drainage improvements within the Chatham Hills Development and to construct additional drainage improvements north of the existing phase of Chatham Hills ("the Project"), all to the benefit of the owners of property within parts of the Horton Drain, the Henry Plew Drain, and the Isaac Jones Drain, (collectively referred to as the "Hortonville Drainage Shed"), which Project is described in the letter of the Hamilton County Surveyor, dated March 4, 2016, which is attached hereto as Exhibit A; and,

WHEREAS, the Developer has agreed to construct the Project in exchange for reimbursement of part of the costs of the Project in the amount of Eighty-two Thousand Seven Hundred Thirty-five Dollars (\$82,735); and,

WHEREAS, it is in the best interest of the health, safety, and welfare of the citizens of Hamilton County and the property owners in the Hortonville Drainage Sheds, that the Drainage Board enter into an Agreement with the Developer to construct the improvements described herein.

IT IS THEREBY AGREED as follows:

 The Developer agrees to construct the drainage pipes shown from Storm STR 2090 to Storm STR 2088, as shown on Exhibit B, with thirty (30") inch RCP pipe.

- 2. The Developer agrees to construct new twenty-four (24") inch RCP pipe from the point shown as Storm STR 2088 to Storm STR 2080, as shown on Exhibit B.
- 3. The Hamilton County Surveyor shall issue a permit to the Developer to work within the Drainage Easements necessary to construct the Project. The Developer shall perform all of the work pursuant to the standards of the Hamilton County Surveyor's Office and the Drainage Board. The Hamilton County Surveyor's Office shall be notified of the completion of the various stages of the project in order to allow inspection and acceptance of the Project.
- 4. Upon dedication of regulated drainage easements, either through platting or dedication; final inspection; and acceptance of the Project, the Drainage Board shall reimburse the Developer Eighty-two Thousand Seven Hundred Thirty-five Dollars (\$82,735) toward the construction costs of the Project.

ALL OF WHICH IS AGREED by and between the Drainage Board and the Developer on the dates set out herein.

Re: Hortonville Drainage

At this time the Board has an opportunity to have a key piece of infrastructure placed which will provide an outlet for Hortonville. The developer for Chatham Hills, Steve Henke, has provided a design for an outlet through his subdivision to the south side of Hortonville. This would provide an outlet to the area south of 206th street and east of Horton Road.

The design is shown on the attached Exhibit 1 labeled "Offsite Drainage, Job No. 2014.01381" by Structurepoint, Inc. The green and red lines are the proposed drain which begins at the retention pond in Section 2A of Chatham Hills, Tract 08-05-23-00-02-107.000, and runs to the southeast corner of the intersection of the Monon with Worman Street in Hortonville. The green line shows what is needed for the Chatham Hills Development and the red line is the additional drain needed to serve Hortonville. Mr. Henke has offered to increase the storm line shown in green from 15" and 24" storm sewer to 30" storm sewer and install the section shown in red as a 24" storm sewer. Mr. Henke would do so with the County paying the cost of the upsizing of the green line along with the additional cost of red line. This is shown on the attached cost estimate. The cost difference the county would pay is \$82,735.00.

Hortonville has had drainage problems for many years. It is served by the Horton Drain which is north of 206th Street and east of Horton Road; the Henry Plew Drain which is north of 206th Street; the Cover Horney Drain which is south of 206th Street and the Isaac Jones Drain located east of Hortonville. This is shown on the attached map labeled "Hortonville Drainage Sheds". In June 2002 the Board received a petition for an arm to the Horton Drain. The major problem of serving the community has been the distance to an adequate outlet. The cost of obtaining easement and installing a facility has been a roadblock to solving the problem. In addition to this, once the existing regulated drain is reached the existing drains would require reconstruction due to their condition and capacity. In the case of the Horton Petition the Horton Drain is only 6 inches in diameter throughout.

The drainage shed for the southeast portion of Hortonville Drain which this proposed drain would serve is 16.2 acres. This area is currently divided by the Little Eagle Creek Drainage Shed and the Isaac Jones Drainage Shed. The Cove Horney Drain has been combined into the Little Eagle Creek Drainage Shed. Both the Henry Plew and the Horton Drains have been combined into the Isaac Jones Drainage Shed. The split between the drainage sheds is 6.12 acres to Little Eagle Creek Drainage Shed and 10.08 acres to the Isaac Jones Drainage Shed. At this time the Little Eagle Creek fund has a balance of \$451,329.03 with collections of \$160,675.18 annually. The Isaac Jones has a negative balance of \$11,415.55 with annual collections of \$46,836.92. I would propose to the Board that the Board pay Chatham Hills, LLP the \$82,735.00 for the installation of the much needed outlet. This cost be paid by both drainage sheds by the percentage of acreage between the two sheds, 37.8% for Little Eagle Creek and 62.2% for Isaac Jones. This would amount to \$31,273.83 for Little Eagle Creek and \$51,461.17 for Isaac Jones. The Isaac Jones portion to be taken from GDIF (General Drain Improvement Fund) and paid back over a 5 year period at a rate of \$10,292.24 per year. This would allow for an annual operations budget of \$36,544.68 per year for the drain until paid back.

With the outlet constructed a system can be designed to complete the system on the southeast portion of Hortonville. In speaking with Chris Allen, CDBG Coordinator, Noblesville Housing Authority, he believes that Hortonville may qualify for CDBG Funding. If this is the case a future project would be funded through traditional methods for the matching funds.

I urge the Board to consider this opportunity to provide the needed outlet as the first step to solving a long standing drainage problem.

The Board, having considered the evidence and objections, and, upon motion duly made, seconded and unanimously carried, did find and determine that the costs, damages and expenses of the proposed Reconstruction will be less than the benefits accruing to the owners of all land benefited by the Reconstruction.

The Board having considered the evidence and objections, upon motion duly made, seconded and unanimously carried, did adopt the Schedule of Assessments as proposed, subject to amendment after inspection of the subject drain as it relates to the lands of any owners which may have been erroneously included or omitted from the Schedule of Assessments.

The Board further finds that it has jurisdiction of these proceedings and that all required notices have been duly given or published as required by law.

Wherefore, it is ORDERED, that the proposed Reconstruction of the *Isaac Jones Drain, Hortonville-Chatham Hills Arm* be and is hereby declared established.

Attached are as-built, certificate of completion & compliance, and other information for the Hortonville-Chatham Hills Arm. An inspection of the drainage facilities for this section has been made and the facilities were found to be complete and acceptable.

During construction, changes were made to the drain, which will alter the plans submitted with my report for this drain-dated June 1, 2016. The report was approved by the Board at the hearing held July 25, 2016. (See Drainage Board Minutes Book 17, Pages 48-50) The changes are as follows: the 24" RCP was shortened from 1,375 feet to 1,224 feet. The 30" RCP was lengthened from 1,031 feet to 1,154 feet. The open ditch was shortened from 400 feet to 391 feet. Therefore, the length of the drain is now **3,584 feet**.

The non-enforcement was approved by the Board at its meeting on July 25, 2016 and recorded under instrument #2016036243 and #2016054068.

The project was a cost share project between the Hamilton County Drainage Board and Henke Development Group. This agreement was approved by the Board on May 26, 2016 (DBM Book 16, Page 556) and per the agreement Henke Development was to be reimbursed for the drain footage reported above. This was in the amount of \$82,735.00 and was completed on March 14, 2017 (check # 2269253).

I recommend the Board approve the drain's construction as complete and acceptable.
