Your Honor

The undersigned Brewer and Engineer
appointed at the last November term of the Circuit
Court held in the Court House in the town of Noblesville
met at the place of beginning of said ditch and
after making personal inspection of the lands described
in the petition and of the lands of the petitioners and
petitioners, and consider the proposed ditch practicable
and when properly constructed will be beneficial to the
public health, and will benefit the public highways which
said improvement may cross, will not materially benefit
any street in town, and will be of public utility and
we believe the costs, damages and expense of effecting the
drainage will be less than the benefits to the owners of the
lands likely to be benefitted by the proposed drainage.
We have determined that an open ditch will be the best
and cheapest method of draining the lands through which
the proposed ditch is to run. The proposed ditch will
commence 791 feet north and 633 feet west of the
East Corner of the South West Quarter of Section 26 Town
19 Range 3 East and run East 633 feet thence South

The above and foregoing Estimates are based upon an open ditch one foot wide in the bottom from Stake 0 to Stake 60 and from Stake 60 to Stake 156 two feet wide in the bottom and from Stake 156 to 173 three feet wide in the bottom and from Stake 173 to 218 four feet wide in the bottom the sides will slope at an angle of 45° degrees. The dirt taken out of the ditch must be removed two feet out side the slopes of the ditch

and the said Commissioners and Engineers further report that they have estimated the benefits and injury to the several tracts of land which will be affected by the work as follows
