During construction, changes were made to the drain which will alter the plans submitted with my report for this drain dated April 10, 1989. The changes are as follows: The 6" SSD was replaced with 4"SSD and therefore was not excepted as regulated drain. This was noted per the inspection letter dated August 27, 1992. Only section 1 has been constructed at this time. The drain total is 752' of 12" RCP.

The length of the drain due to the changes described above is now 752 feet.

Note: The Luther Cravens drain was vacated from sta 0 to sta 14+00. Section Three of the April 10, 1989 report was found to be complete and acceptable with no significant changes to the original report. Therefore, this portion will add

an additional 740' feet to the Clara Knotts Drain. The non-enforcement was approved by the Board at its meeting on August 21,




TYPICAL STREET
