Re: Little Eagle Creek Drain, 146th Street Extension

Attached is a drain map, drainage shed map and schedule of assessments for the extension of the Little Eagle Creek Drain. This proposed drain is located in Clay and Washington Township.

I have made a personal inspection of the land described below. Upon doing so, I believe that the drain is practicable, will improve the public health, benefit a public highway and be of public utility and that the costs, damages and expenses of the proposed drain will probably be less than the benefits accruing to the owners of land likely to be benefited. The drain will consist of the following:

Open Ditch 176 ft.

The total length of the drain will be 176 feet.

The extension will begin at the existing north Right of Way line of 146<sup>th</sup> Street and extend across to the south Right of Way line of 146<sup>th</sup> Street.

The current rates for the Little Eagle Creek Drain are \$10.00 per acre for roads. The annual maintenance collection for this extension will be \$65.70.

I believe this proposed drain meets the requirements for Urban Drain Classification as set out in IC 36-9-27-67 to 69. Therefore, this drain shall be designated as an Urban Drain.

The nature of maintenance work required is as follows:

- 1. Bank crosion protection and/or seeding as might be required;
- 2. Removal of debris and/or blockages from existing open drain;

- 3. Removal of beaver dams;
- 4. Any other repairs necessary to restore proper flow to the open ditch.

The frequency with which maintenance work should be performed is annually as required by the condition of the drain.

The easements for the drain should be set at 75' from top of bank as set out in IC 36-9-27-33.

I recommend that the Board set a hearing for this proposal for May 29, 2007.

## FINDINGS AND ORDER FOR RECONSTRUCTION

The matter of the proposed Reconstruction of the *Little Eagle Creek Drain*, 146<sup>th</sup> Street Extension came before the Hamilton County Drainage Board for hearing on May 29, 2007, on the Reconstruction Report consisting of the report and the Schedule of Damages and Assessments. The Board also received and considered the written objection of an owner of certain lands affected by the proposed Reconstruction, said owner being:

Evidence was heard on the Reconstruction Report and on the aforementioned objections.

The Board, having considered the evidence and objections, and, upon motion duly made, seconded and unanimously carried, did find and determine that the costs, damages and expenses of the proposed Reconstruction will be less than the benefits accruing to the owners of all land benefited by the Reconstruction.

The Board having considered the evidence and objections, upon motion duly made, seconded and unanimously carried, did adopt the Schedule of Assessments as proposed, subject to amendment after inspection of the subject drain as it relates to the lands of any owners which may have been erroneously included or omitted from the Schedule of Assessments.

The Board further finds that it has jurisdiction of these proceedings and that all required notices have been duly given or published as required by law.

Wherefore, it is ORDERED, that the proposed Reconstruction of the Little Eagle Creek Drain,  $146^{\rm th}$  Street Extension be and is hereby declared established.

Thereafter, the Board made inspection for the purpose of determining whether or not the lands of any owners had been erroneously included or excluded from the Schedule of Assessments. The Board finds on the basis of the reports and findings at this hearing as follows:

## CERTIFICATE OF ASSESSMENTS FOR ANNUAL MAINTENANCE

TO THE AUDITOR OF HAMILTON COUNTY

WE CERTIFY THAT THE SCHEDULE OF ASSESSMENTS ATTACHED, HERETO HAS BEEN ADOPTED PURSUANT TO Indiana Code, recodified 1982, to provide funds for annual maintenance of the above named drain; that due notice thereof has been published; that the period of time within which a judicial review could be requested has expired; and that the order of the Drainage Board fixing the assessment on each tract of land is now conclusive.

The assessments stated in the attached schedule are annual assessments and shall be collected year after year until such assessments are terminated or changed by order of the Drainage Board. Each annual assessment shall be due and payable in May and in November in each year. The first installment shall be due and payable in May 2008.

All such installments may be paid without interest, but if not paid when due shall be subject to the same rate of penalty applicable to delinquent taxes.

The County Auditor is directed to enter the assessment according to this certification to the Ditch Duplicate of the county for collection by the County Treasurer.
