BRENDELL ET AL DRAIN= REPORT OF VIEWERS AND ENGINEER OF THE ORRIS E= BRENDELL ET AL DRAIN= To the Honorable Judge of the Hamilton Circuit Court:

We the Viewer and Engineer to whom the above entitled petition for drainage of certain lands in Washington Township, Hamilton County, Indiana, was referred; would respectfully 22.7%report, that we met on the line of the ditch on the 22.md day o. Febuary 1951, qualified and proceeded to view said drain and lands affected thereby. After careful investigation of the premises of said drain we are of the opinion that said drain should be constructed, and done in the manner set out below, in the report and that the same when completed will improve the public health, and will reclaim certain lands and will be a public utility, and will benefit several highways; also, that the cost of construction demages and expenses of affected said drain will be less than the benefits to the lands affected by said drainage.

That we have definitely determined the best and cheapest method of affecting the drainage of such lands. We have fixed the route, location and character of said proposed work; that we have fixed the same by metes and bounds, courses, distances,

descriptions and guides and bench marks so as to provide for a complete outlet for the drainage of said lands affected by the proposed work; that we have divided the ditch into sections of not more than 100 feet in length by setting stakes each 100 feet.

<u>LOCATION</u> The main ditch terminates approximately two miles southwest of Eagletown near the northeast corner of the Little Eagle Creek Church and Cometery properties, then in an easterly and southeasterly direction. The beginning point being approximately 860 feet north and six feet west of the southeast corner of the northwest quarter of section 17, township 18 north, range 3 east. APPROXIMATES 4050'

Arm #1. Station 6 begins 375.0 ft south of the northeast corner of the west half of the northeast quarter, section 17, township 18 north, range 3 east, running thence in a westerly northwesterly and southwesterly course terminating in Main ditch where open portion starts, approximately 1328.0 ft. west and 560.0 ft south of the northeast corner of the northwest quarter, section 17, township 18 north, range 3 east.

Arm #2. Begin approximately 900 ft north of the southeast corner of west half of southeast quarter of section 8, township 18 north, range 3 east; thence in a westerly and southwesterly direction terminating in Arm #1 658.0 ft west and 139.0 ft. north of southeast corner of southwest quarter, section 8, township 18 north, range 3 east. Approximately 2250'

The said ditches are now in place and need repairing.

RECOMMENDATION. Repair the three existing tile ditches now in place, also install 3-10" Beehive Inlets on the 12" tile. At the end of the tile take up and relay into the higher ground and extend using 20 lineal feet of 15" corrugated pipe on the 12" tile and 12" corrugated pipe on the 10" tile. At the end where tile terminates construct a headwall and slab of concrete 8' wide and 10' long 6" thick for spillway. Also install 3-8" Beehive Inlets on 8" ditch as directed by Engineer. From end of tile construct open ditch following the old channel except straightening as indicated in profile, 3 feet wide bottom 1 to 1 slopes, dirt to be leveled with bulldozer not to exceed 2 feet depth unless authorized by Engineer. All grubs, shrubs, stumps and stone to be removed. Stumps shrubs and debris to be piled and burned before acceptance of job.

Right-of-way to be wide enough to take care of dirt on one side of ditch. All concrete work to be  $1-2\frac{1}{2}-4$  mix; one cement  $2\frac{1}{2}$  sand and 4 gravel.

The work to all be done in a neat and workmanlike manner.

All tile to be clay, concrete or shale and shall meet the A.S.T.M. specifications. The work will be under the supervision of the County Surveyor or his authorized assistant.

All ditch for tile shall be cut 6" larger than the largest diameters of tile. Lay tile and cover enough to hold tile in place. No tile to be fully covered until **6**.K.'d by Engineer.

Shale, Clay or Concrete tile will be accepted.

Corrugated pipe shall be 16 gauge.

The Contractor shall furnish Bond or Certified Check to guarantee completion of work and carry Compensation Insurance protecting Hamilton County from any damages from injury or damages whatever.

RIGHT-OF-WAY. The right-of-way shall be wide enough to take care of dirt, to be spread on one side of ditch and all trees and brush upon the right-of-way must be removed. Trees and shrubs to be removed at least 5 feet from bank of ditch. <u>And Burnesc</u>. The sipes shall be 1 perpendicular to 1 horizontal as near as practicable, and must be maintained throughout the ditch as elsewhere designated in these plans, any excessive depths and bottom widths that are cut by the Contractor shall have the corresponding slope required for the width and cut so made. The Engineer and Drainage Commissioner shall be the Judge of all slopes and the same must be cut to their satisfaction.

When said drain is in old channel, the present banks are not to be disturbed, uhless so directed by the superintendent.

The ditch shall be maintained throughout its entire length by the Contractor and no portion will be accepted as complete until total is accepted.

Acceptance of the grade on any portion of the ditch shall not be final until the ditch is complete and is such

manner as to conform as nearly as possible to the full intent of the plans, profiles and specifications for same and is free from any obstruction that hinders or impedes the flow of the water.

<u>SUPPLEMENT</u> Trees on the right-of-way will only be moved at the descretion of the Engineers. Theyeare a bunch of evergreen trees which have been s et out along each side of ditch which must be taken care of in some manner by the

contractor.

Attached is a drain map, drainage shed map and assessment roll for the Orris E. Brendell Drain. This drain is located in Sections 7,18,17,8 Twp 18N R 3E in Washington Township. This drain consists of both open and tile drain of approximately 9,600 feet in lenght being constructed by Court order in 1952.

After an inspection of the drain and a survey of the open portion of the drain it was found that some work is needed on the drain. The attached work order shows what is planned at this time for the tile portion. Although the open portion needs some work I would recommend that it be postponded at this time. As you can see by the attached survey the drain has adequate grade. I also recommend extending the legal drain from its present terminus at the North East corner of the Little Eagle Creek Cemetery to the intersection of Little Eagle Creek, which would add an additional

With 342.80 acres in the drainage shed being assessed for maintenance at \$2.00/ac with a \$6.00 minimum. The total yearly assessment will be \$7.06.00. Because of the work needed at this time, I recommend a special assessment of \$3.00/ac with \$10.00 minimum be assessed the first year to cover this work. This assessment will total \$1,069.00.

I recommend a maintenance hearing be set for 1:35pm on September 6, 1983.

#### PETITION FOR DRAIN

We, the undersigned, respectfully petition this Honorable Court and would represent and show that we constitute more than ten per cent (10%) in acreage of the land owners of acreage of land lying outside of the corporate limits of any town or city in the State of Indiana, which will be affected by the drainage herein petitioned for, and we respectfully petition this Honorable Court to establish and construct a drain or ditch over the lands hereinafter described in Washington Township, Hamilton County, Indiana, the general course of said drain being as follows:

> Beginning at a point about seventy (70) rods east and about twenty (20) rods north of the center of Section seventeen (17), Township eighteen (18) north, Range three (3) east at a point at or near where a certain tiled drainage stops. Run thence in a northwesterly direction along said tiled drainage to an open ditch located about eighty (80) rods west and thirty (30) rods south of the northeast corner of the northwest quarter of Section seventeen (17), said Township and Range: run thence in a general westerly direction following said open drain to the public highway running north and south along the west side of said quarter section; thence in a general northwesterly direction following said open drainage to Little Eagle Creek, said point being the point where said open drainage empties into said creek and being about seventy (70) rods west and twenty (20) rods north of the northwest corner of said quarter section.

Also an arm extending from the east end of said open drainage being about eighty (80) rods west and thirty (30) rods south of the northeast corner of the northwest quarter of said Section seventeen (17) and run thence in a northeasterly direction following the course of a certain tiled drain to a point near the northeast corner of said quarter section.

That said drainage should be performed and accomplished by tiling said open drain with tile of good quality of sufficient size to adequately drain the lands affected by this drainage, and that those portions of said drainage which are already tiled should be repaired and placed in good condition to perform the services intended and if necessary should be retiled with larger tile of sufficient size to adequately drain all the lands affected thereby, or if necessary by changing their course or extending the same if necessary.

That the inadequacey of said drain causes damage to agricultural crops; that in the opinion of your petitioners by construction of said drain the public health will be improved. That as said drainage now exists certain public highways are now overflowed and inundated to some extent and said public highways will be benifited by said proposed drainage and that said proposed work and drainage will be of public utility.

That your petitioners believe that they have set forth herein enough of the work in describing the route of the proposed drain so that length thereof shall be equal to four-fifths (4/5) or more of the aggregate length of the work to be reported for construction.

That the costs, damages and expenses of the drainage will be less than the benifits which will result to the owners of the lands likely to be benifited thereby.

That said drainage can not be accomplished in the best and cheapest manner without affecting the lands of others who are hereinafter designated.

That for the purpose of constructing and repairing said drain and also affectively draining said lands along said proposed drain which are hereinafter described the same can be accomplished by tiling said open portion of said drain and if necessary and where needed by enlarging the tile of said portion of said drain already tiled and by reconstructing said drain all in such manner as to affectively drain all lands hereinafter described.

That negotiations have been had with agents of the United States Government and it is deemed apparent and possible that Federal aid will be extended under and by virtue of the Civilian Conservation Corps for the rehabilitation of said public drain, all of which is desired if possible by the petitioners herein.

Said petitioners would further show that the names of the owners
