Re: Elizabeth Lynch Drain – Arcadia Christian Church Arm

Attached is a reconstruction petition filed by the Arcadia Christian Church along with an outlet request, plans, and calculations for the Elizabeth Lynch Drain – Arcadia Christian Church Arm to be located in Jackson Township, parcel #03-02-13-00-009.004. I have reviewed the submittals and petition and have found each to be in proper form.

I have made a personal inspection of the land described in the petition. Upon doing so, I believe that the drain is practicable, will improve the public health, benefit a public highway, and be of public utility and that the costs, damages and expenses of the proposed drain will be less than the benefits accruing to the owners of land likely to be benefited. The drain will consist of the following:

12" RCP from structure LD-1 to LD-2, LD-2 to LD-3, LD-3 to LD-4, LD-4 to LD-5.

12" RCP 1378 ft.

The total length of the drain will be 1378 feet

The new drain will be 1378 feet in length. The existing section of the Arm 1 of Arm 1 of the Elizabeth Lynch from station 30+50 to station 34+83 will be removed. This will remove 433 feet. Therefore 945 feet will be added to the overall length of the drain.

The description of the drain as shown on the construction drawings for the Arcadia Christian Church Addition prepared by Falcon Engineering, Job number 208.0, dated April, 2006, is as follows:

From structure LD-5 northwest, parallel to State Road 19 and 15' east of the State Road 19 Rightof-Way, 583 feet of 12" RCP to structure LD-4. From structure LD-4 northwest, 362 feet of 12" RCP to structure LD-3 where it intersects of Arm 1 of Arm 1 of the Elizabeth Lynch Drain at approximately station 34+83. From structure LD-3 northeast 423 feet, following the course of Arm 1 to Arm 1 of the Elizabeth Lynch Drain to Structure LD-2. From structure LD-2 northnortheast 10' to Structure LD-1 where it intersects the original tile of Arm 1 to Arm 1 of the Elizabeth Lynch Drain at station 30+50.

The petitioner has submitted surety for the proposed drain at this time. The surety which is in the form of a Performance Bond is as follows:

I recommend that upon approval of the above proposed drain that the Board also approve the attached non-enforcement request. The request is for the reduction of the statutory 150' regulated drain easement to 30 feet in width being 15' parallel from the centerline of the following described drain.

Beginning at the intersection of an existing 8 inch clay tile being the centerline of the Arm 1 of Arm 1 of the Elizabeth Lynch Drain, and a 12 inch RCP; thence southerly along the centerline 12 inch RCP to a point 15 feet south of the termination of the 12 inch RCP

I recommend the Board approve the proposed drain at this time.

said petition advises	the Board that:	

- 1. Petitioner owns real estate through which a portion of the <u>Elizabeth Lynch Regulated</u> Drain runs.
- 2. Petitioner plans to develop its real estate with roads, buildings, utilities, storm drains, sanitary sewers and other structures.
- Petitioner's proposed development of its real estate will require relocation and reconstruction of a portion of the <u>Elizabeth Lynch Regulated</u> Drain, as specifically shown on engineering plans and specifications filed with the Hamilton County Surveyor.
  - 4. The work necessary for the proposed relocation and reconstruction will be undertaken at the sole expense of the Petitioner and such work will result in substantial improvement to the <u>Elizabeth Lynch Regulated</u> Drain, without cost to other property owners on the watershed of the <u>Elizabeth Lynch Regulated</u> Drain.
  - 5. Proposed relocation and reconstruction will not adversely affect other land owners within the drainage shed.
  - Petitioner requests approval of the proposed relocation and reconstruction under IC 36-9-27-52.5.

WHEREFORE, Petitioner requests that an Order issued from the Hamilton County Drainage Board authorizing relocation and reconstruction of the \_\_\_\_\_Elizabeth Lynch Regulated Drain, in conformance with applicable law and plans and specifications on file with the Hamilton County Surveyor.

## Re: Elizabeth Lynch Drain: Arcadia Christian Church Arm

Attached are as-builts, certificate of completion & compliance, and other information for Arcadia Christian Church Arm. An inspection of the drainage facilities for this section has been made and the facilities were found to be complete and acceptable.

During construction, changes were made to the drain, which will alter the plans submitted with my report for this drain-dated April 2, 2008. The report was approved by the Board at the hearing held May 27, 2008. (See Drainage Board Minutes Book 11, Pages 153-154) The changes are as follows: The 12" RCP was lengthened from 1378 to 1380 feet. The length of the drain due to the changes described above is now **1380 feet**. It should be noted that the original tile was removed between Sta. 3+73 to Sta. 8+06. Therefore, the overall watershed was lengthened by 947 feet.

The easements were outlined in my above mentioned report to the board. This report was approved and the easement width between Structures LD5 to LD3 shall be 30 feet in total width. It should be noted that a non-enforcement was not requested for this project.

The following sureties were guaranteed by Bond Safeguard and released by the Board on its May 27,2008 meeting.

I recommend the Board approve the drain's construction as complete and acceptable.






