Re: John Owen Drain

Attached is a drain map for the extension of the John Owen Drain. This proposed drain is located in Noblesville Township. This extension is mentioned in my Drain Classification dated April 20, 2009 and approved by the Board on April 27, 2009.

I have made a personal inspection of the land described below. Upon doing so, I believe that the drain is practicable, will improve the public health, benefit a highway and be of public utility and that the costs, damages and expenses of the proposed drain will probably be less than the benefits accruing to the owners of land likely to be benefited. The drain will consist of the following:

Open Ditch - 1,758 feet

The extension shall begin at a point of termination described in the original petition for the John Owen Drain, dated June 18, 1936. Said point of termination being 1305 feet south and 58 feet east of the northwest corner of the northeast quarter of the northwest quarter of Section 15, Township 19 North, Range 4 East; said point also being 118 feet southeast of the northwest corner of Lot 51 of Carlton Heights, Section 3. Thence running downstream within the existing open ditch 1,758 feet through Carlton Heights Sections 3 and 1 to the west line of Lot 5 in Carlton Heights Section 1.

Platted drainage easements exist on each of the lots involved per the plat for Carlton Heights, Sections 1 (Lots 5, 6, 7, 8, 9, 10, 11, 12, & 13) as recorded in the office of the Hamilton County Recorder on August 26, 1987 in Plat Book 14, pages 71-72 and Carlton Heights Section 3 (Lots 42, 43, 44, 45, 46, 47, 53, 54 & 55), as recorded in the office of the Hamilton County Recorder on November 16, 1999 in Plat Cabinet 2, Slide 354. Therefore, I believe that no damages will result due to the regulating of this drain.

Also this extension of the John Owen Drain affects the parent parcel from which Carlton Heights, Section 3 was platted. Parcel Number 11-06-15-00-002.001. The north line of Carlton Heights, Section 3 meanders from side to side of the existing open ditch. The proposed easement for this parent parcel from the point of beginning of this extension to the point where the open channel turns south into the platted Carlton Heights, Section 3 shall be from bank to bank, plus 75 feet in width from the top of the north bank of the open drain as set out in IC 36-9-27-33.

According to FEMA Flood Insurance Rate Map Number 18057C0130F, this area is not covered by floodplain.

The Board further finds that it has jurisdiction of these proceedings and that all required notices have been duly given or published as required by law.

Wherefore, it is ORDERED, that the proposed Reconstruction of the John Owen Drain, Extension be and is hereby declared established.

Thereafter, the Board made inspection for the purpose of determining whether or not the lands of any owners had been erroneously included or excluded from the Schedule of Assessments. The Board finds on the basis of the reports and findings at this hearing as follows:




I appreciate your openness in discussing the drain extension and its effect/lack of effect on our property and improvements.
