Dear Mr. Hurlock:

This is in connection with recent meeting with you by our representative from Division Engineer Strode's office regarding our Bridge No. 19.77 located over a small stream in Noblesville Township about two miles south of Noblesville, Indiana.

As outlined, our present timber trestle carrying our track across the stream is in need of replacement and we are proposing to replace it with a structural plate culvert pipe. The drainage area above our structure is about 600 acres. Using an index of 0.4, which is conservative for the terrain at this location, the waterway area required for a 4" rain is 44 square feet. We propose to install one line of 96" diameter structural plate pipe, which provides a waterway area of 50 square feet, remove our timber trestle and fill the remaining area.

Your review of this proposal would be appreciated. It is hoped you will favor us with an early reply, furnishing your comments on approval, so this work can be started in the near future.


## Dear Sir:

After investigating the tie-in request of Mr. Ron McIllvain for the Jean Nay property, I have found that the proposed tile will not overload the existing legal drain.







Upon inspection of the relocation of McMahan-Overdorf Regulated Drain September 9, 1986, the following items need to be completed.

- 1. Construct flowline of Ditch as per enclosed profile.
- 2. Spoil needs leveled on East Bank between ditch and fence.
- 3. Rip Rap needs embedded into ditch bank and needs to be at least one (1') foot thick. Rip Rap should not protrude above flowline of ditch.
- 4. Rip Rap needs to be placed higher on ditch banks to prevent erosion of ditch bank.




