#### Requirements,

Ditch to consist of one row of 8 inch drain tile from station 0 to station 6 and one row of 10 inch drain tile from station 6 to station 23 and one row of 12 inch drain tile from station 23 to station 34+55 and one row of 12 inch sewer tile from station 34+55 to station 34+65. Where same terminates in what is known as the Emery Clark Ditch.

#### Retaining wall.

At station 34+65 to be built a concrete retaining wall, said.

well to be loxex5 feet and to be built of concrete mixed one to

five. Clean sharp sand and clean gravel shall be used and a good

quality of portland cement. The forms for the face side and ends shall

be of dressed lumber so that the face of the well will be smooth and

require no plastering. The base of the well shall be set 18 inches

below the grade of the tile.

## Laying tile, filling ditch, deadining & etc.

All tile used in this ditch shall be first class quality and subject to the inspection of the Superintendent in charge of the work. They shall be laid in the trench in a true line with joints well matched and at proper grade as shown on the profile hereto attached and made a part of this report, and left uncovered until inspected and accepted by the Superintendent, after which the trench shall be filled full and tamped so that no settlement may occur. At or near station 23 the contractor will be required to connect the 8 inch tile already in place to the new ditch. Where the new ditch follows the old tile drain already in place the contractor will be required to take up the old tile and lay same on the ditch bank. The old tile t remain the property of the land owner on which the tile are located. All trees to be deadened and bushes cut for a distance of 25 fect on each side of the ditch. All work to be done in a first class and workmanlike manner and to the full satisfaction of the Superintendent
