Re: Morrow-Follett Drain, R.J. Follett Arm, Monon Square Vacation. Station 0+00 to 6+00

Attached is a petition to abandon a portion of the Morrow Follett Drain, R.J. Follett Arm by the City of Carmel. The proposal is to abandon a portion of the existing drain on parcels 16-09-25-00-00-014.004, owned by Village Housing Corporation and 16-09-25-00-014.000 and 16-09-25-00-00-014.002 owned by Carmel Midtown Community Development Corporation.

The portion of the R.J. Follett Arm of the Morrow-Follett Drain to be vacated will begin at the southern limits of the project area at Sta. 0+0 per the drains 1928 description. The drain then runs north for 600 feet before stopping at Station. 6+00 per the drains 1928 description. At this time, the catch basin that the drain is connected to at Station 6+00 (Str. 202) will not be vacated. This is the upstream portion of the drain.

The request will remove 600 feet of 18-inch tile.

The vacation is part of a larger effort to redevelop the parcels into a mixed-use district known as Monon Square. With the approval of Monon Square, the City of Carmel will be installing drainage infrastructure which converges into a main trunkline in the location of the existing Morrow-Follett Drain (Carmel Project No. 20-ENG-13). Maintenance of the new stormwater infrastructure will be the responsibility of the City of Carmel. Upon approval of the project, contractors will remove the existing 600 feet of the Morrow-Follett Drain within the subdivision to the existing manhole at Station 6+00 at the northern limits of the project which is also just north of the property line of existing parcel #16-09-25-00-00-014.002.

Upon review of the request, I believe the above portion of the drain meets the requirements for vacation as set out in IC-36-9-27-34(d). In my opinion, the vacation will not adversely affect other property owners within the drainage shed.

I recommend the Board set a hearing date for January 22, 2024.

The limits of the requested easement vacation are the most southern extents of the drain west of Rangeline Rd, just north of City Center Drive to Walnut Street. A portion of the drain south of Walnut will be reconstructed as part of City of Carmel Project No. 20-ENG-13. An Exhibit of the easement limits is attached.

The City of Carmel will take over the responsibility of any future maintenance of the drain in the relinquished easement.
