Re: Mud Creek -- Sand Creek Drainage Area, EE Bennett Arm, 146th & Olio Road Roundabout Relocation

Attached are petition by Brueckmann, Charitable Remainder Unitrust Trustee Hillsdale College, file stamped May 18, 2020, and plans for the proposed reconstruction of a portion of the Mud Creek – Sand Creek Drainage Area, EE Bennett Arm. This project is to be paid for by the City of Noblesville. In order to a facilitate improvements to the 146th & Olio Road intersection, the proposal is to reconstruct and relocate the existing drain per the construction plans by Butler, Fairman & Seufert (BF&S) Civil Engineers called “City of Noblesville – Olio Road & 146th Street Road Plans,” dated 7/10/2020, BF&S project No. 6126.

Per the plans by BF&S, the drain relocation will begin near the east right-of-way line of Olio Road, approximately 557’ south of 146th street centerline. The existing EE Bennett Arm drain tile will be intercepted at a new storm manhole (Str 199). New RCP will drain north towards the proposed roundabout. At a manhole on the south side of the roundabout (Str 203), the drain will turn west, where it will continuc west of Olio Road, paralleling 146th street along the south right of way. Approximately 800’ west of the centerline of Olio Road, the pipe will flow into a new open ditch. The open ditch will flow west for about 450’, then turn south to eventually discharge into the existing detention area in Saxony Corporate Campus, which is part of the existing EE Bennett Arm. Per the plans, the relocation will occur between Str 199 and the above-mentioned pond (BF&S station 42+07). These locations correspond with the original stations 80+15 and 96+00 of the EE Bennett Drain installed in 1901.

The relocation will consist of the following:

- 484’ of 15” RCP
- 898’ of 72” RCP
- 1907’ of open drain

The length of the relocation will be 3,289'. This project will add 1,704' to the overall length of the Mud Creek – Sand Creek Drainage Area, EE Bennett Arm. The existing 1585' of tile drain installed in 1901 between existing stations 80+15 and 96+00 will be vacated.

Per the project plans, this relocation project involves the following structures: 199, 200, 203, 208, 202, 206, and 206-A, as well as, the open new open ditch. The other storm facilities constructed with the 146th & Olio Road Roundabout project will be owned and maintained by the City of Noblesville or the landowners.

The drain will be reconstructed on the following parcels:
Within the right-of-way of Olio Road, owned by the City of Noblesville; Within the right-of-way of 146th Street, owned by the City of Noblesville; Parcel No. 13-11-23-00-00-007.000 (Brueckmann Cornett Subdivision, Block Pt A) owned by Brueckmann, F Robert & Betty Lee Charitable Remainder Unitrust Trustee Hillsdale College; and Parcel 13-11-23-00-00-011.034 (Saxony Corporate Campus) owned by Saxony Corporate Campus Association, Inc.


Regarding easement, this project is proposed to be constructed within existing right-of-way and drain easement acquired by the City of Noblesville from Hillsdale College, Brueckmann, Charitable Remainder Unitrust Trustee (Instrument No 2020041877), as well as, existing easement in Saxony Corporate Campus, as recorded in the office of the Hamilton County Recorder.

The original E. Bennett Drain was established per Commissioner's Court records in March 1901 (CR13, page 118). In 2003, the EE Bennett Drain was reconstructed through the Noblesville Corporate Campus as per my report "EE Bennett Drain and the Republic Arm" dated April 25, 2003 and approved by the Drainage Board at hearing on May 27, 2003. See Drainage Board Minutes Book 7, pages 69-74. In 2007, the EE Bennett Drain was made an arm of the Mud Creek – Sand Creek Drainage Area per my report dated May 1, 2002 and was approved by the Board on June 27, 2007. See Minutes Book 10, pages 324-325.

The cost of the project is to be paid by the City of Noblesville. Therefore, the requirement for posting surety has been waived.

I recommend the Board set a hearing for November 23, 2020.

PETITION FOR RELOCATION AND RECONSTRUCTION

Brueckmann, charitable remainder unitrust trustee Hillsdale College (hereinafter "Petitioner"),

hereby petitions the Hamilton County Drainage Board for authority to relocate and improve a section of the EE Bennett Drain, and in support of said petition advises the Board that:

1. Petitioner owns real estate through which a portion of the EE Bennett Drain runs.
2. Petitioner plans to develop its real estate with roads, buildings, utilities, storm drains, sanitary sewers and other structures.
3. Petitioner's proposed development of its real estate will require relocation and reconstruction of a portion of the EE Bennett Drain, as specifically shown on engineering plans and specifications filed with the Hamilton County Surveyor.
4. The work necessary for the proposed relocation and reconstruction will be undertaken at the sole expense of the Petitioner and such work will result in substantial improvement to the EE Bennett Drain, without cost to other property owners on the watershed of the EE Bennett Drain.

WHEREFORE, Petitioner requests that an Order issued from the Hamilton County Drainage Board authorizing relocation and reconstruction of the EE Bennett Drain, in conformance with applicable law and plans and specifications on file with the Hamilton County Surveyor.





The matter of the proposed Reconstruction of the **Mud Creek/Sand Creek Drainage Area, E. E. Bennett Arm, 146th & Olio Road Roundabout Relocation** came before the Hamilton County Drainage Board for hearing on **November 23, 2020**, on the Reconstruction Report consisting of the report and the Schedule of Damages and Assessments. The Board also received and considered the written objection of an owner of certain lands affected by the proposed Reconstruction, said owner being:

Evidence was heard on the Reconstruction Report and on the aforementioned objections.

The Board, having considered the evidence and objections, and, upon motion duly made, seconded and unanimously carried, did find and determine that the costs, damages and expenses of the proposed Reconstruction will be less than the benefits accruing to the owners of all land benefited by the Reconstruction.

The Board having considered the evidence and objections, upon motion duly made, seconded and unanimously carried, did adopt the Schedule of Assessments as proposed, subject to amendment after inspection of the subject drain as it relates to the lands of any owners which may have been erroneously included or omitted from the Schedule of Assessments.

The Board further finds that it has jurisdiction of these proceedings and that all required notices have been duly given or published as required by law.

Wherefore, it is ORDERED, that the proposed Reconstruction of the **Mud Creek/Sand Creek Drainage Area, E. E. Bennett Arm, 146th & Olio Road Roundabout Relocation** be and is hereby declared established.


The Board issued an order declaring the proposed improvement established. Such findings and order were marked filed and are available for inspection in the Office of the Hamilton County Surveyor.


Attached are as-builts and other information for 146th St & Olio Rndbt Relocation. An inspection of the drainage facilities for this section has been made and the facilities were found to be complete and acceptable.

During construction, changes were made to the drain, which will alter the plans submitted with my report for this drain-dated September 11, 2020. The report was approved by the Board at the hearing held November 23, 2020. (See Drainage Board Minutes Book 19, Pages 395-397) The changes are as follows: the 15" RCP was lengthened from 484 feet to 485 feet. The 72" RCP was lengthened from 898 feet to 918 feet. The open ditch was shortened from 1907 feet to 1896 feet. The length of the drain due to the changes described above is now **3299 feet**. The original 12" drain tile from station 80+15 to 96+00 was vacated with this project.

A non-enforcement was not required for this project. The relocation of the drain was constructed within existing road right of way and drainage easement obtained by the City of Noblesville (See recorder's instrument #2020041877). A surety was not required for this project as it was paid for by the City of Noblesville.

I recommend the Board approve the drain's construction as complete and acceptable.


