Re: Mud Creek – Sand Creek Drainage Area, EE Bennett Arm, Residence Inn Reconstruction

Attached are petition by MHG Hotels, and plans for the proposed reconstruction and relocation of a portion of the Mud Creek – Sand Creek Drainage Area, EE Bennett Arm. This project is to be paid for by the developer. In order to facilitate site improvements for a hotel, the proposal is to reconstruct the existing drain per the construction plans by Terra Site Development called "Residence Inn – Noblesville" file dated 8/1/2022, Project No. 2109001.

The proposed reconstruction is located northwest of the intersection of Tegler Blvd (141st) and Olio Road. Per the plans by Terra Site Development, a portion of the existing EE Bennett Arm open ditch will be piped along the south and west sides of the Residence Inn site on parcel 13-11-23-00-00-007.001 (Brueckman Cornett Subdivision Block A, owned by Ravi LLC). Approximately 20' of the upstream end of the drain reconstruction will occur on the adjacent parcel 13-11-23-00-00-008.001 (Brueckman Cornett Subdivision Block B, owned by Cornett Management Company LLC; Cornett, Janice Jean Rev Trust; Mays, Carol L Living Trust). The downstream end of the reconstruction will connect to an existing storm pipe at existing Str. 301 near the northwest corner of the hotel parcel, where the existing open ditch currently ends. This existing storm pipe is part of the existing 2010 Olio Road – I-69 Bridge Arm to the EE Bennett Drain.

The reconstruction will consist of the following:

1,022' of 54" RCP

The length of the reconstruction will be 1,022. This project will add 68' to the overall length of the Mud Creek – Sand Creek Drainage Area, EE Bennett Arm. The existing 954' of open ditch on this site installed in 2010 as part of the EE Bennett: Olio Road – I-69 Bridge Arm will be vacated.

Per the project plans, this relocation project involves the following structures: Bypass Inlet 1A, MH01, MH02, MH03, MH04 and MH05. The other storm facilities constructed with the Residence Inn project will be owned and maintained by the landowners.

Regarding easement, a non-enforcement has been submitted for approval. The request is for the easement dimensions to be 40' total width (20' per half as measured from the centerline of the pipe). I recommend approved of the non-enforcement at this time.

This proposal for Residence Inn includes a variance request (DV-2022-00016) which is also addressed in a separate staff report. The request is for the sanitary sewer line to be allowed a separation of 8.5' where it crosses below the new 54" storm pipe, instead of the required 10' separation. The proposed sanitary sewer pipe will be connecting to an existing sanitary manhole.

The original E. Bennett Drain was established per Commissioner's Court records in March 1901 (CR13, page 118). In 2003, the EE Bennett Drain was reconstructed through the Noblesville Corporate Campus as per my report "EE Bennett Drain and the Republic Arm" dated April 25, 2003 and approved by the Drainage Board at hearing on May 27, 2003. (See Drainage Board Minutes Book 7, pages 69-74). In 2007, the EE Bennett Drain was made an arm of the Mud Creek – Sand Creek Drainage Area per my report dated May 1, 2002 and was approved by the Board on June 27, 2007. (See Minutes Book 10, pages 324-325). In 2010, a portion of this drain was reconstructed as the EE Bennett: Olio Road – I-69 Bridge Arm (See Drainage Board Minute Book 12, pages 61-65).

The cost of the project is to be paid by the developer. The petitioner has not yet submitted surety for the proposed drain reconstruction at this time. Per the Board's policy, if approved, I recommend the developer submit surety in the amount of 120% of the engineer's estimate for the above reconstruction.

This proposal meets the criteria for reconstruction of a regulated drain as laid out in IC-39-9-27-52.0. I recommend the Board set the hearing for October 24, 2022.



FINDINGS AND ORDER

CONCERNING THE PARTIAL VACATION OF THE

On this 24th day of October, 2022, the Hamilton County Drainage Board has held a hearing on the Maintenance Report and Schedule of Assessments of the Mud Creek/Sand Creek Drainage Area, E. E. Bennett Arm, Residence Inn Reconstruction (Olio Road-I-69 Bridge Arm - 954').

Evidence has been heard. Objections were presented and considered. The Board then adopted an order of action. The Board now finds that the costs of continued maintenance to the portion of the above drain exceed the benefits to the real estate benefited by the portion of the drain to be abandoned and issues this order vacating the above section of the Mud Creek/Sand Creek Drainage Area, E. E. Bennett Arm, Residence Inn Reconstruction (Olio Road-I-69 Bridge Arm - 954').

FINDINGS AND ORDER FOR RECONSTRUCTION

The matter of the proposed Reconstruction of the *Mud Creek/Sand Creek Drainage Area, E. E. Bennett Arm, Residence Inn Reconstruction* came before the Hamilton County Drainage Board for hearing *on October 24, 2022,* on the Reconstruction Report consisting of the report and the Schedule of Damages and Assessments. The Board also received and considered the written objection of an owner of certain lands affected by the proposed Reconstruction, said owner being:

Evidence was heard on the Reconstruction Report and on the aforementioned objections.

The Board, having considered the evidence and objections, and, upon motion duly made, seconded and unanimously carried, did find and determine that the costs, damages and expenses of the proposed Reconstruction will be less than the benefits accruing to the owners of all land benefited by the Reconstruction.

The Board having considered the evidence and objections, upon motion duly made, seconded and unanimously carried, did adopt the Schedule of Assessments as proposed, subject to amendment after inspection of the subject drain as it relates to the lands of any owners which may have been erroneously included or omitted from the Schedule of Assessments.

The Board further finds that it has jurisdiction of these proceedings and that all required notices have been duly given or published as required by law.

Wherefore, it is ORDERED, that the proposed Reconstruction of the Mud Creek/Sand Creek Drainage Area, E. E. Bennett Arm, Residence Inn Reconstruction

be and is hereby declared established.

Thereafter, the Board made inspection for the purpose of determining whether or not the lands of any owners had been erroneously included or excluded from the Schedule of Assessments. The Board finds on the basis of the reports and findings at this hearing as follows:
