Attached is a petition, non-enforcement and plans for the proposed relocation of the Margaret O'Brien Drain. The relocation is being proposed by Erie Indianapolis Florida. LLC (Erie). The proposal is to relocate a portion of the temporary open ditch which was constructed with the original Crosspointe Development. This temporary ditch will be filled and relocated across the Erie property with a new 48" RCP along the east property line along Crosspointe Blvd. And a temporary open ditch along the north property line.

The line will consist of the following:

48" RCP 818 ft.

The total length of new storm sewer shall be 818 feet. The 790 feet of original temporary drain between the existing outlet of 48" RCP north of Centerpoint Drain and the north line of the Erie property shall be vacated. This proposal will add an additional 28 feet to the drains total length.
