REVIEWERS' REPORT OF JOHN R. COLLINS DITCH NO. 2.

TO THE HONORABLE BOARD OF COMMISSIONERS OF HAMILTON COUNTY, INDIANA:

We, the undersigned, appointed by this Court, at its April Regular Term 1902, to review a drain described in the certified copy of a petition and order of Court for a drain by John R. Collins and others, handed us by the Auditor, would represent that according to said order we, on the day named therein, to-wit: the 28th day of April, 1902, met and were qualified according to said order, and proceeded to review the action and report of the Viewers, as well as the entire premises through which the proposed work extends, and, after a careful and actual view of all premises and due consideration of all points set forth in the remonstrances handed us by the Auditor, submit the following Report:

We believe the proposed work as located by the Viewers to be of public benefit and utility, and that the cost of construction will be less than the benefits to be derived therefrom, and hereby report no changes in location.

We have set out, by a statement below, the names of the owners of lands benefited, with a description of each tract of land and the amount assessed against each tract, the amount of credits and damages we believe to be due, the depth of cut, the width of bottom and width at top along said drain and the total number of cubic yards of earth to be removed from said drain, and the manner in which the work shall be done is also shown in this report.

The estimated cost is the same as shown in Viewers' report, being \$630.00.

LOCATION.

By a ditch commencing 511 feet East of the N.W. cor. of the S.E. 1/4 of section 22, Tp. 18 N., Range 3 east, Hamilton County, Ind. Running thence S. 5° W. to stake 3+70, thence S. 45-1/2° E. to stake 5+58, thence S. 62° E. to stake 8, thence S. 76° E. to stake 15, thence S. 26° E. to stake 16, thence S. 55° E. to stake 17+53; thence N. 68-1/2° E. to stake 18, thence N. 53-1/2° E. to stake 19+45, thence S. 36-1/2° E. to stake 22+40, thence S. 63-1/2° E. to stake 24+50, thence S. 19-1/2° E. to stake 26, thence S. 8-1/2° E. to stake 29, thence S. 25° E. to stake 31+75, thence S. 69-1/2° E. to stake 32+75, thence 85-1/2° E. to stake 34+91, thence S. 41-1/2° E. to stake 45+37, thence S. 15° E. to stake 49+73, thence S. 1-1/2° E. to stake 63+35, thence S. 16° W. to stake 65, thence S. 48-1/2° W. to stake 66, thence S. 72° W. to stake 71+30, thence S. 78-1/2° W. to stake 74, thence S. 75-1/2° W. to stake 83+70, thence S. 30° W. to stake 94, and terminating 800 feet south and 200 feet west of the S.W. cor. of the E. 1/2 of the S.E. Section 27, township 18 north, Range 3 east, Hamilton County, Indiana.

Said ditch to be 3 feet wide in bottom, with side slopes 1 to 1 or 45° and shall be constructed true to the line of the established grade, and slopes. All material excavated from ditch and banks to be deposited not nearer than two feet from the edge or break of the banks. At all such places as the ditch crosses the old channel, or runs along one side of the old channel the earth excavated from the ditch shall be placed in and along in such a manner so as to form a good new channel that the water will be kept in its proper course. All bushes and trees to be grubbed and removed from the ditch and outside the two feet from break of banks.

All work to be done to the full satisfaction of the County Surveyor.

The length of the ditch as located is 9400

We, the Reviewers, would further report that in our opinion it would be impracticable to allot said ditch for construction for the reason that if allotted there would be a great number of small allotments and the cost of receiving the same would be a great expense, and the work would be better and quicker done and at a less cost to the parties assessed, to sell the ditch in one contract. Therefore, we recommend that said work be sold by the Auditor of the County as provided by law in such cases.

Said Ditch to be cut to right hand side of stakes, looking down stream, and shall be cut true to the line of stakes as staked by Reviewers.

Except that in the construction the line of ditch shall be varied so as to miss the end fence Post mentioned in the Remonstrance of John Hinshaw Said Post being at or near Stake 22 ~~etc~~
