During construction, changes were made to the drain which will alter the plans submitted with my report for this drain dated January 7, 1988. The changes are as follows:

The corrected total of 12" RCP is 1842' feet.

The length of the drain due to the changes described above is now 4687 feet.

The non-enforcement was approved by the Board at its meeting on July 24, 1989.
