

Attached are plans and the schedule of assessments for the reconstruction of the Park Northwestern Drain.

This Drain was constructed originally in 1980 and is currently on a maintenance program. Reconstruction is required at this time due to the siltation of the swale and detention area, failure of the subsurface drain and the proposed reconstruction of St. Rd. 421.

The reconstruction will consist of the following items:

- A. Installing 8" subsurface drain from the North side of Northwestern Drive through the detention area and outletting on the West side of the basin into the 27" RCP installed as part of the drainage system for Mayflower Transit in Boone County.
- B. Installing a 43" x 27" RCP under Northwestern Drive to replace the existing pipe.
- C. Install twin 27" RCP's as outlets to the detention area.
- D. Regrade open ditch and detention area North of Northwestern Drive.

Items B and C are needed in order to provide for the additional flows for the proposed reconstruction of S.R. 421.

Due to the project being within already platted easements, no damages to landowners will result by the reconstruction of this drain. Therefore, damages shall be set at \$0.00.

The cost of the new pipe under Northwestern Drive; the new 27" pipe at the county line and the 18" pipe South of Northwestern Drive is due to the State's proposed reconstruction of S.R. 421 and the higher rates of flow which will result because of the work. Therefore, the cost of this work, \$58,380.00, shall be assessed to the State Highway as a special assessment.

The remainder of the cost, \$39,773.00 shall be spread over the entire drainage shed. I have reviewed the plans and believe the drain will benefit each tract equally. Therefore, I recommend each tract be assessed equally. I recommend each tract within the drainage shed be assessed \$230.00 per acre without a minimum assessment for reconstruction.

Currently the drain is assessed for maintenance at a rate of \$20.00 per acre, \$20.00 minimum which brings in \$2,282.40 annually. Current balance in the maintenance fund is \$7,710.12. Therefore, I recommend no increase in the annual maintenance assessment.

I believe this proposed drain meets the requirements for Urban Drain Classification as set out in IC 36-9-27-67 to 69. Therefore, this drain shall be designated as an Urban Drain.

I recommend a hearing be set for this proposal on August 23, 1999






