

Attached are as-builts, certificate of completion & compliance, and other information for Villages at Pebblebrook Sec. 2. An inspection of the drainage facilities for this section has been made and the facilities were found to be complete and acceptable.

During construction, changes were made to the drain which will alter the plans submitted with my report for this drain dated November 16, 1992. The changes are as follows: Structure 207-207A was an additional structure which consists of 3' feet of 12" RCP. Structure 207A-206 consists of 15" RCP which was shortened from 127' to 124' feet. Structure 200-202A was an additional structure which consists of 7' feet of 12" RCP.

The length of the drain due to the changes described above is now 6,857 feet.

The non-enforcement was approved by the Board at its meeting on January 19, 1993 and recorded under instrument # 9302864.

The bond or letter of credit from INB, number 035845, dated June 24, 1992, in the amount of \$61,907.00, has expired.

I recommend the Board approve the drains construction as complete and acceptable.
