Re: Shelborne Greene Drain, 106th and Shelborne Road RAB Reconstruction

Attached are a petition, plans, and shed map for the proposed reconstruction of the Shelborne Greene Drain. The reconstruction is being proposed by the Hamilton County Highway Department. The proposal is to reconstruct the drain to provide drainage for the 106th Street and Shelborne Road Round-a-bout. The reconstruction is as shown per plans by Corradino, LLC, having Job No. PR-08-0002, and dated August 11, 2010.

The reconstruction will add new drain from existing Str. 125 of the Huntersfield Section 1 Arm of the Shelborne Greene Drain to Str. 146 and then to Str. 154 of the road plans.

The new drain for the round-a-bout project will consist of the following:

12" RCP 156 ft.

The total length of new drain shall be 156 feet.

The cost of the reconstruction was paid by the Hamilton County Highway Department.

The Hamilton County Highway Department was not required to provide surety.

I believe this proposed drain meets the requirements for Urban Drain Classification as set out in IC 36-9-27-67 to 69. Therefore, this drain shall be designated as an Urban Drain. With this reconstruction, 0.63 acres should be removed from the Shelborne Green Drain and added to the Crooked Creek Drain. Since the road acreage assessment is \$10.00 per acre for each, this will result in no net change for the road assessments to the City of Carmel.

The easement for this drain will be the existing right of way for 106^{th} Street and Shelborne Road, along with the platted drainage easement shown on the secondary plat for Huntersfield (PC 1, Slide 457) as recorded in the Office of the Hamilton County Recorder.

I recommend the Board set a hearing for this proposed drain for November 28, 2011.

FINDINGS AND ORDER FOR RECONSTRUCTION

The matter of the proposed Reconstruction of the **Shelborne Greene Drain, 106th and Shelborne Road RAB Reconstruction** came before the Hamilton County Drainage Board for hearing **on November 28, 2011**, on the Reconstruction Report consisting of the report and the Schedule of Damages and Assessments. The Board also received and considered the written objection of an owner of certain lands affected by the proposed Reconstruction, said owner being:

Evidence was heard on the Reconstruction Report and on the aforementioned objections.

The Board, having considered the evidence and objections, and, upon motion duly made, seconded and unanimously carried, did find and determine that the costs, damages and expenses of the proposed Reconstruction will be less than the benefits accruing to the owners of all land benefited by the Reconstruction.

The Board having considered the evidence and objections, upon motion duly made, seconded and unanimously carried, did adopt the Schedule of Assessments as proposed, subject to amendment after inspection of the subject drain as it relates to the lands of any owners which may have been erroneously included or omitted from the Schedule of Assessments.

The Board further finds that it has jurisdiction of these proceedings and that all required notices have been duly given or published as required by law.

Wherefore, it is ORDERED, that the proposed Reconstruction of the Shelborne Greene Drain, 106th and Shelborne Road RAB Reconstruction be and is hereby declared established.

Thereafter, the Board made inspection for the purpose of determining whether or not the lands of any owners had been erroneously included or excluded from the Schedule of Assessments. The Board finds on the basis of the reports and findings at this hearing as follows:


The Board issued an order declaring the proposed improvement established. Such findings and order were marked filed and are available for inspection in the Office of the Hamilton County Surveyor.

Re: Shelborne Green: 106th & Shelborne Rd RAB Reconstruction

Attached are as-builts, certificate of completion & compliance, and other information for 106th & Shelborne Rd RAB Reconstruction. An inspection of the drainage facilities for this section has been made and the facilities were found to be complete and acceptable.

During construction, changes were made to the drain, which will alter the plans submitted with my report for this drain-dated October 11, 2011. The report was approved by the Board at the hearing held November 28, 2011.

The changes are as follows:

The design of the road project was changed. Therefore, the proposed extension to the existing Shelborne Green Drain was not constructed. Therefore, the length of the drain due to the changes described above is now **0 feet**.
