


The proposed relocation involves the installation of a 42" RCP in order to relocated 115 feet of the existing open ditch along the perimeter of the tract. The cost of this work will be paid by Mr. Atwell, the petitioner. The drainage system will intercept the existing open ditch along the South line of the tract and re-connect into the existing system at the 43x27 inch CMPA. The new system will consist of two (2) manholes, 1 4x4 junction box, five (5) feet of 15" RCP and 192' of 42" RCP. This will add 72 feet to the drain.

Attached are as-builts, certificate of completion & compliance, and other information for Willowview Drain Relocation. An inspection of the drainage facilities for this section has been made and the facilities were found to be complete and acceptable.

During construction, changes were made to the drain which will alter the plans submitted with my report for this drain dated September 26, 1993. The changes are as follows: The drain now consists of the following: 2 concrete boxes at 5.7' x 5.7', and 189.4' feet of 42" Concrete Pipe. The existing 43" x 27" CMPA was removed. The 15"RCP was not constructed.

The additional length of the drain due to the changes described above is now 79.6 feet.

A non-enforcement was not required.


The bond or letter of credit was not required. All relocation costs were paid for by the petitioner.


