Re: Sly Run Drain, Bliss Johnson Arm

Upon review of the drainage sheds, I believe that the Bliss Johnson Drain should be made an arm to the Sly Run Drain as the Bliss Johnson Drain is a tributary to the Sly Run Drain. This would also avoid a double assessment on the tracts currently assessed for the Bliss Johnson Drain when the remainder of the Sly Run Drain is assessed for maintenance.

The Bliss Johnson Drain was created per the viewers report dated July 27, 1940 and approved by Hamilton County Circuit Court. At present the Bliss Johnson Drain maintenance assessment affects 345.34 acres and 333 lots. The rate of assessment for the drain is set at \$10.00 per acre for roads, and \$2.00 per acre with a \$15.00 minimum for residential and agricultural, \$5.00 per acre with a \$35.00 minimum for unregulated subdivision, \$10.00 per acre with a \$65.00 minimum for regulated subdivisions, \$10.00 per acre with a \$75.00 minimum for commercial. This rate collects \$13,980.94 annually and the balance within the fund is \$79,579.10. There are no outstanding work orders for this drain at this time.

The current maintenance assessment will revise as per the rates set for the Sly Run Drain which are as follows:

- 1. Maintenance assessment for roads and streets are set at \$10.00 per acre.
- 2. Maintenance assessment for agricultural tracts are set at \$2.00 per acre with a \$15.00 minimum.

- 3. Maintenance assessment for non-platted residential tracts are set at \$2.00 per acre with a \$15.00 minimum.
- 4. Maintenance assessment for commercial, institutional and multi-family residential tracts are set at \$10.00 per acre with a \$75.00 minimum.
- 5. Maintenance assessment for platted lots in subdivisions whose drainage systems will not be part of the regulated drain shall be set at \$35.00 per lot/minimum. Common areas within non-regulated drain subdivisions shall be assessed at \$5.00 per acre with a \$35.00 minimum.
- 6. Maintenance assessment for platted lots within subdivisions whose drainage system will be part of the regulated drain shall be set at \$65.00 per lot/minimum. Common areas within the regulated drain subdivisions shall be set at \$10.00 per acre with a \$65.00 minimum.

The total annual assessment for this arm will be \$13,980.94.

The current balance of the Bliss Johnson Drain shall be kept separate and these funds expended for needed maintenance on the Bliss Johnson Drain. This shall be done until the funds are exhausted. At that time funding for repairs shall then be taken from the Sly Run Drain fund. Collections for the Sly Run Drain will begin May 2012.

Future assessments for the drainage area of the Bliss Johnson Drain will be made into the Sly Run Drain fund. No further maintenance collections for the Bliss Johnson Drain shall be made.

I recommend that the Board set a hearing for this consolidation for February 28, 2011.


