TO: Hamilton County Drainage Board

RE: Stony Creek Drain, Union Chapel Road Area.

At this time the City of Noblesville is extending Union Chapel Road north to State Road 32. As part of the project new storm sewer is being installed to drain the new pavement and run the storm water south into Stony Creek. This will also change the drainage shed for the Elwood Wilson Drain by removing some area from the Wilson Shed to the Stony Creek Shed.

The area which should be removed from the Elwood Wilson Drain is as follows:

Hamilton County Highway	Promise Road	Remove 0.93 acres
Indiana Dept. of Transportation	State Road 32	Remove 11.37 acres

Attached is the schedule of assessment for the additional area to be assessed for this additional drainage shed. The new area of assessment will produce an assessment of \$759.98.

I recommend the Board set this hearing on June 27, 2011.

FINDINGS AND ORDER


CONCERNING THE MAINTENANCE OF THE




