#### RE: Thistlewaite Drain - Partial Vacation Request

The Hamilton County Surveyor's Office is requesting a partial vacation for the Thistlewaite Drain. The request is for a portion of the tile drain that has been removed and replaced with a relocated open drain.

The Thistlewaite Drain was reconstructed in 1908 (Hamilton County Circuit Court cause # 14573 filed April 25, 1908). The section of the drain that is proposed to be vacated was bypassed during the 1996 reconstruction and had been provided an outlet into the new open ditch and retained as part of the regulated drain per my report dated August 1, 1996 (Hamilton County Drainage Board Minutes, Book 4, Page 297B). The vacation is being proposed due to the construction of the Sheridan Estates Subdivision which removed the section of by-passed tile. The proposed vacation will vacate 776 feet of regulated drain which consisted of 15" clay tile.

The portion of the Thistlewaite Drain to be vacated is as follows:

Thistlewaite Drain Main Ditch (1908 reconstruction). From Station 33+70 to Station 41+46, 15" Clay Tile.

I believe that the requested partial vacation meets the requirements for vacation as set out in IC 36-9-27-34. I recommend the Board set a hearing for this item as set out in IC 36-9-27-37(a) for February 23, 2009.

#### FINDINGS AND ORDER FOR RECONSTRUCTION

The matter of the proposed Reconstruction of the **Thistlewaite Drain, Partial Vacation** request came before the Hamilton County
Drainage Board for hearing on **February 23, 2009**, on the Reconstruction
Report consisting of the report and the Schedule of Damages and
Assessments. The Board also received and considered the written
objection of an owner of certain lands affected by the proposed
Reconstruction, said owner being:

Evidence was heard on the Reconstruction Report and on the aforementioned objections.

The Board, having considered the evidence and objections, and, upon motion duly made, seconded and unanimously carried, did find and determine that the costs, damages and expenses of the proposed Reconstruction will be less than the benefits accruing to the owners of all land benefited by the Reconstruction.

The Board having considered the evidence and objections, upon motion duly made, seconded and unanimously carried, did adopt the Schedule of Assessments as proposed, subject to amendment after inspection of the subject drain as it relates to the lands of any owners which may have been erroneously included or omitted from the Schedule of Assessments.

The Board further finds that it has jurisdiction of these proceedings and that all required notices have been duly given or published as required by law.

Wherefore, it is ORDERED, that the proposed Reconstruction of the **Thistlewaite Drain, Partial Vacation Request** be and is hereby declared established.

Thereafter, the Board made inspection for the purpose of determining whether or not the lands of any owners had been erroneously included or excluded from the Schedule of Assessments. The Board finds on the basis of the reports and findings at this hearing as follows:
