## RE: Thorpe Creek Drainage Area, A. J. Myers Drain Arm

Upon review of the drainage sheds I believe that the A. J. Myers Drain should be made an arm to the Thorpe Creek Drainage Area. I recommend this action as the A. J. Myers Drain is a tributary to the Thorpe Creek Drainage Area. This would also avoid a double assessment on the tracts currently assessed for the A. J. Myers Drain when the remainder of the Thorpe Creek Drainage Area is assessed for maintenance.

On October 3, 1983 the Board held a hearing on my report dated July 5, 1983 to establish the drain maintenance assessment for the A. J. Myers Drain. (See Drainage Board Minutes Book 1, Page 563). The original rate of assessment for the drain was set at \$2.00 per acre with a \$6.00 minimum. Assessment rates were increased per my reconstruction report dated June 10, 2002 which was approved by the Board at hearing on July 22, 2002 (See Hamilton County Drainage Board Minutes Book 6, Pages 399-402). The rates set at that time were as follows:

- 1. Maintenance assessment for roads and streets \$10.00 per acre with a \$25.00 minimum.
- 2. Assessment for platted lots and common areas in subdivisions whose drainage systems will not be part of the regulated drain. Those systems maintained by the (Town of Fishers) shall be set at \$15.00 per acre with a \$25.00 per lot/minimum.
- 3. Assessments for platted lots and common areas in subdivisions whose drainage system will be part of the regulated drain shall be set at \$10.00 per acre with a \$50.00 per lot/minimum.
- 4. Assessment for acreage shall remain at \$2.00 per acre with a \$6.00 minimum. This shall include agricultural lands and non-platted residential tracts.
- 5. Assessment for commercial, industrial and institutional tracts shall be set at \$35.00 per acre with a \$75.00 minimum.

At May 22, 2006 hearing the minimum rate for residential and agricultural was increased From \$6.00 to \$15.00; the minimum rate for unregulated subdivisions was increased from \$25.00 to \$35.00; and the minimum rate for regulated subdivisions was increased from \$50.00 to \$65.00.

This rate collects \$6,174.12 annually for Hamilton County and \$561.93 for Madison County. The balance within the fund is \$16,126.67

The proposed maintenance assessment would decrease as per the rates set for the Thorpe Creek Drainage Area which are as follows:

- 1. Maintenance assessment for roads and streets be set at \$10.00 per acre.
- 2. Maintenance assessment for agricultural tracts be set at \$2.00 per acre and \$15.00 minimum.
- 3. Maintenance assessment for non-platted residential tracts be set at \$2.00 per acre and \$15.00 minimum.
- 4. Maintenance assessment for platted lots within subdivisions whose drainage system will be part of the regulated drain shall be set at \$75.00 per lot/minimum. Common areas within the regulated drain subdivisions shall be set at \$10.00 per acre with a \$75.00 minimum.
- 5. Assessment for platted lots and common areas in subdivisions whose drainage systems will not be part of the regulated drain. Those systems maintained by the Town of Fishers shall be set at \$5.00 per acre with a \$35.00 per lot/minimum.
- 6. Assessment for commercial, industrial and institutional tracts shall be set at \$10.00 per acre with a \$75.00 minimum.

A portion of the drainage shed for this drain is within Madison County. Madison County waived their right to a Joint Board during the maintenance hearing in 1983.

The current balance of the A. J. Myers Drain shall be kept separate and these funds expended for needed maintenance in the length of Thorpe Creek covered by the current A. J. Myers Drain.

Future assessments for the drainage area of the A. J. Myers Drain will be made into the Thorpe Creek fund. No further maintenance collections for the A. J. Myers Drain fund shall be made.

All future maintenance work on the A. J. Myers Drain should be paid from the Thorpe Creek fund once the balance of the A. J. Myers Drain fund is depleted.

I recommend that the Board set a hearing for this consolidation for April 27, 2009.

Dear Hamilton County Drainage Board:

I received the notification letter of the maintenance report of the County Surveyor (copy enclosed). The annual cost of maintaining the drain is \$6,245.74.

Our Britton Falls Area lot is one of over 200 hundred completed home lots with an estimated 1,000 completed homes over the next few years.

Considering the annual cost of maintenance, the existing and future Britton Falls homes, the surrounding homes associated with Thorpe Creek maintenance, it seems like a lot more assessment revenue is being created than the \$6,245.74 required.

Could you provide more information to me? I'm not particularly opposed to the assessment, but it would be helpful to understand how many Britton Falls home lots are being assessed as an unregulated subdivision and the other assessed revenues generated from non-Britton Falls properties involved in the Thorpe Creek maintenance as assessed by the Drainage Board.
