RE: THE COMMISSIONERS INSTRUCTED THE AUDITOR TO CALL JAMES NEFF, ON THE NUMBER OF CULVERTS THRU GRADE ABOVE NORTHERN WOODS BEACH. THEY CLAIM IT IS GOING TO RUN MORE SURFACR WATER ON THEM.

RE: COOL CREEK. COUNTY SURVEYOR, ROY HORNEY, INSTRUCTED TO DRAW UP A SKETCH TO SHOW THE INTENT OF THE CHANGE IN THE COOL CREEK ON THE FARM OF MIER BLOCK. THE AMENDMENT WAS SIGNED BY THE COMMISSIONERS.

RE: PLANS & SPECIFICATIONS FOR CHANEL CHANGE OF COOL CREEK & KIRKENDALL DRAIN.

THE FOLLOWING IS THE SPECIFICATIONS FOR THE CHANNEL CHANGE OF COOL CREEK:

SPECIFICATIONS FOR THE CHANNEL CHANGE OF COOL CREEK

SPECIFICATIONS FOR THE CHANNEL CHANGE OF COOL CREEK ON THE M. S. BLOCK FARM, PT SE 1/4 Sec. 32 Tp 18 N, R 4E, WHERE COOL CREEK CROSSES THE GRAY ROAD RUNNING N & S.

BEGIN AT THE WEST SIDE OF COOL CREEK BRIDGE, THENCE IN WESTERLY DIRECTION CHANGING CHANNEL AS PER PLANS AND STAKES ON GROUND.

A NEW CHANNEL, 20 FT. WIDE BOTTOM, WITH SLOPES 2 TO 1. ALL EXCAVATION TO BE PUT IN OLD CHANNEL, FILLING TO ORIGINAL GROUND ELEVATION AND SLOPING TO THE NATURAL GROUND ELEVATION ON SOUTH SIDE OF NEW CHANNEL.

AT THE UPPER END WHERE NEW CHANNEL STARTS BUILD DAM OF LOGS, STONE AND DEBRIS ACROSS CHANNEL TO DIRECT FROM OLD CHANNEL TO NEW.

ANY PLACES ON NORTH BANK OF NEW CHANNEL NEEDING FILL - WILL FILL. THE BALANCE TO GO INTO OLD CHANNEL AND COVERED UP.

WHEN EXCAVATIONS AND FILLS ARE COMPLETED ALL SHALL BE LEVELED OFF AND SLOPED FROM OLD BANK TOWARD NEW CHANNEL.

AT NORTHWEST CORNER OF BRIDGE USE RIP RAP WITH STONE APPROXIMATELY 50 FT. FOR PROTECTION OF NORTH ABUTMENT.

THERE ARE SEVERAL DEAD TREE LIMBS AND DEBRIS ALONG THE CREEK BANK. CONTRACTOR SHALL CLEAN UP AND DEPOSIT SAME IN OLD CHANNEL. THERE ARE 5 OR 6 LARGE TREES TO BE TAKEN OUT, THE SALABLE LOGS SHALL BE THE PROPERTY OF THE OWNER IF HE WANTS THEM. IF HE DOES NOT WANT THEM THEY WILL BE THE PROPERTY OF THE CONTRACTOR. THE CONTRACTOR SHALL DISPOSE OF THE STUMPS, LIMBS AND DEBRIS - ALL TO BE DEPOSITED IN THE OLD CHANNEL, THEN COVERED UP WITH EXCAVATION.

IF THE LAND OWNER DOES NOT WANT THE LOGS THE CONTRACTOR SHALL PUT THEM IN ONE PILE ON THE NORTH BANK OF CREEK WHERE THEY CAN BE GOTTEN TO FOR LOADING. ALL WORK IS TO BE DONE IN A NEAT WORKMANLIKE MANNER.

THE CONTRACTOR IS TO FURNISH ALL EQUIPMENT, LABOR AND MATERIAL TO MAKE A COMPLETE JOB. CONTRACTOR IS TO COMPLY WITH ALL LAWS AND REGULATIONS PERTAINING TO CONTRACTS WITH THE COUNTY.

SPECIFICATIONS FOR THE CHANNEL CHANGE OF COOL CREEK AT THE FLOWING WELL

AT THE MILDRED SELINGER FARM BEGIN APPROXIMATELY 100 FT. SOUTH OF THE SOUTH SIDE OF THE BRIDGE. TAKE OUT ALL SAND, GRAVEL AND DEBRIS TO 6" BELOW WATER ELEVATION. CLEAN OUT UNDER THE EAST SPAN OF THE BRIDGE AND MAKE NEW CHANNEL CONNECTING WITH ORIGINAL COOL CREEK CHANNEL APPROXIMATELY 300 FT. NORTH OF BRIDGE AS PER PLANS AND SPECIFICATIONS.

CLEAR BANK ON WEST SIDE OF NEW CHANNEL 25 FT. AND ALL BRUSH, SHRUBS AND DEBRIS BETWEEN EAST SIDE OF NEW CHANNEL AND EAST BANK OF OLD CHANNEL - ALL BRUSH AND DEBRIS TO BE DEPOSITED IN OLD CHANNEL AND COVERED WITH EXCAVATION. ALL EXCAVATIONS ARE TO BE DEPOSITED IN OLD CHANNEL WITH RIP RAP, ETC. WHERE NEW CHANNEL TAKES OFF. INTO NEW CHANNEL, AT NORTHWEST CORNER OF BRIDGE FILL WITH RIP RAP APPROXIMATELY 50 FT. NORTH TO PROTECT BRIDGE ABUTMENT, ALL WORK TO BE DONE IN A NEAT AND WORKMAN LIKE MANNER.
