Re: Kirkendall Drain - Mary Cox Arm

Upon reviewing the drainage shed for the Kirkendall Drain, I have notice that part of the Mary Cox Drain is in the watershed for the Kirkendall Drain. Due to the development growth and that the Mary Cox Drain is not currently on maintenance, I recommend that the remaining portion of the Mary Cox Drain be made part of the Kirkendall Drain, Mary Cox Arm.

The new Kirkendall Drain, Mary Cox Arm, will be from Sta. 48+33 to Sta. 67+33 of the original Mary Cox description from 1884. The tile portion of the Mary Cox Drain (See Surveyor's report dated June 23, 2003, Drainage Board Minutes Book 7, pages 98 and 99) will also become part of the Kirkendall Drain, Mary Cox Arm.

The drain shall also be extended from Sta. 67+33 of the original Mary Cox description from the 1884, to the north right of way of 161st Street. This extension will include 32 feet of twin 84" CMP pipes under 161st Street and 445 feet of open ditch. This new extension will place statutory easements on parcels 10-10-09-00-00-033.000, owned by Eric & Leah Teitsma and 10-10-09-00-00-034.000, owned by Jack Z. & Margaret L. Kwasniewski.

The total length of new drain shall be 477 feet. The total length of 3528 feet of the Mary Cox Drain will be added to the Kirkendall Drain. The 150 feet of 15" tile from the original Mary Cox Drain between Sta. 10+00 and Sta. 11+50 shall be vacated. This section of the Mary Cox Drain was missed in my report to the Board on June 23, 2003 (See Drainage Board Minutes Book 7, pages 98 and 99).

I believe this proposed drain meets the requirement for Urban Drain Classification as set out in IC 36-9-27-67 to 69. Therefore, this drain shall be designated as an Urban Drain.

Upon review of the drainage assessments for the Kirkendall Drain, I found that the assessment rate for roadway should be adjusted.

I recommend that the assessment rate be increased from \$2.00 per acre for roadways to \$10.00 per acre. This will increase the current annual assessment from \$51.28 to \$256.40 for the Hamilton County Highway, from \$55.80 to \$279.00 for Indiana Department of Transportation, and from \$32.64 to \$163.20 for the Town of Westfield. These roadways have not been accepted yet by the appropriate governmental entity and will increase the current annual assessment from \$73.38 to \$366.90 for Langston Construction, \$94.98 to \$474.90 for Crossmann Communities, \$83.94 to \$419.70 for Arbor Investments, \$35.46 to \$177.30 for Throgmartin-Henke Development, and \$12.48 to \$62.40 for Carey Glen LLC.

The total annual assessment for this new length of drain will be \$2007.38. This includes the increased assessment for the roadways in the Kirkendall Drain and the parcel assessments for the new drain. The assessment roll is attached to this report.

The assessment rates for the tracts currently assessed to the Kirkendall Drain shall remain the same.

I recommend this hearing be set for March 28, 2005.

FINDINGS AND ORDER FOR RECONSTRUCTION

The matter of the proposed Reconstruction of the **Kirkendall Drain, Mary Cox Arm** came before the Hamilton County Drainage Board for hearing on **September 12**, **2005**, on the Reconstruction Report consisting of the report and the Schedule of Damages and Assessments. The Board also received and considered the written objection of an owner of certain lands affected by the proposed Reconstruction, said owner being:

Evidence was heard on the Reconstruction Report and on the aforementioned objections.

The Board, having considered the evidence and objections, and, upon motion duly made, seconded and unanimously carried, did find and determine that the costs, damages and expenses of the proposed Reconstruction will be less than the benefits accruing to the owners of all land benefited by the Reconstruction.

The Board having considered the evidence and objections, upon motion duly made, seconded and unanimously carried, did adopt the Schedule of Assessments as proposed, subject to amendment after inspection of the subject drain as it relates to the lands of any owners which may have been erroneously included or omitted from the Schedule of Assessments.

The Board further finds that it has jurisdiction of these proceedings and that all required notices have been duly given or published as required by law.

Wherefore, it is ORDERED, that the proposed Reconstruction of the Kirkendall Drain, Mary Cox Arm be and is hereby declared established.

Thereafter, the Board made inspection for the purpose of determining whether or not the lands of any owners had been erroneously included or excluded from the Schedule of Assessments. The Board finds on the basis of the reports and findings at this hearing as follows:
