RE: Williams Creek Drain - J.R. Collins Arm - Partial Vacation

Attached is a partial vacation request and ALTA survey submitted by DePauw University and Earlham College, joint owners of parcels 16-09-26-00-001.000 and 16-09-26-00-002.000 in Clay Township.

The portion of the J.R. Collins Drain to be vacated is the main drain from Sta. 0+00 to Sta. 6+00 per the original 1890 legal description.

The proposed vacation will remove 600 feet of 6" tile from the total length of the J.R. Collins Arm of Williams Creek Drain.

The adjacent Illinois Street has its own storm sewer system that collects the ROW and discharges into the pond at Parks at Spring Mill, so no ROW runoff utilizes this drain. The grass ROW area for U.S. 31 is drained by the remaining portion of the main drain and Arm 1 of the J.R. Collins Drain. The only drainage area benefited by this portion of this drain is the 2 parcels owned by the petitioner.

When these 2 parcels are sold for commercial development, they will be installing their own storm sewer conveyance and detention system for their on-site water, which then will discharge back into the J.R. Collins Arm, at their south property line.

Arm 1 of the J.R. Collins Drain, which connects at Sta. 6+00 of the main drain and runs north easterly will remain in place, as it provides a drainage outlet for parcels not controlled by the petitioners.

This will not change the current assessments for the Williams Creek Drainage Area on these parcels.

I believe that the requested partial vacation meets the requirements for vacation as set out in IC 36-9-27-34(d).

I recommend the Board set a hearing for this item as set out in IC 36-9-27-37 for November 23,

2015.
