Re: J. R. Collins #1 Drain

Attached is a petition and plans for the proposed relocation of the J. R. Collins #1 Drain. The relocation is being proposed by CMC Properties. The proposal is to intercept the main drain at the north property line at Sta. 8+00 and re-route the drain through the detention ponds and new storm sewer and outlet at Str. 727 of the relocation described in my report dated September 12, 1988 for Hamilton Crossing West, Phase II. Arm 2 shall be intercepted at the west right-of-way for U. S. 31 which is Sta. 12+40 and shall be re-routed in the same manner.

The line will consist of the following:

18" RCP 150 ft

24" RCP

607 ft

Open Ditch

510 ft

The open ditch listed above is that portion of the system which runs through the detention ponds located in the north east corner of the site and along the south edge of the site. The distance is a straight line distance between Structures 718 and 719, 701 and 710 and 710 and 721 as shown on the attached plan.

The total length of new system shall be 1,117 feet. The 1,480 feet of the original 1890 drain between Sta. 8 and 15 on the main drain and Sta. 12+40 and Sta. 13 of Arm 2 shall be vacated. This proposal will remove 363 feet to the drains total length.

The cost of the relocation is to be paid by CMC Properties. Because the project is to be paid by the petitioner and is within the boundaries of the petitioners property the project falls under the requirements as set out in IC 36-9-27-52.5. Therefore, a hearing is not required for the petition.






