Re: Williams Creek Drain, Spring Mill Run Arm - Cedar Point Extension

Attached is a drain map for the Williams Creek Drain, Spring Mill Run Arm - Cedar Point Extension. This proposed drain is located in Clay Township.

I have made a personal inspection of the land described below. Upon doing so, I believe that the drain is practicable, will improve the public health, benefit a highway and be of public utility and that the costs, damages and expenses of the proposed drain will probably be less than the benefits accruing to the owners of land likely to be benefited. The drain will consist of the following:

Open Ditch – 1,419 feet

The Williams Creek Drain, Spring Mill Run Arm - Cedar Point Extension shall begin at the north right of way line of I-465. The beginning point is the current terminus of the Williams Creek Drain, Springmill Run Arm 1, per my report dated January 28, 2010 and approved by the Board at hearing on March 22, 2010 (See Hamilton County Drainage Board Minutes Book 12, Pages 449 to 450). Thence run upstream within the existing Spring Mill Run channel 1,419 feet to the west property line of parcel 17-13-10-03-01-030.000, owned by James & Barbara Arlington.

The nature of maintenance work required is as follows:

1. Bank erosion protection and/or seeding as might be required;
2. Removal of debris and/or blockages from existing open drain;
3. Removal of beaver dams;
4. Any other repairs necessary to restore proper flow to the open ditch.

The frequency with which maintenance work should be performed is annually as required by the condition of the drain.

The easement for the drain on the parcels should be set per the platted drainage easement as shown on the plat for Cedar Point, as recorded in the office of the Hamilton County Recorder (Plat Book 6, Pages 131 to 132). Therefore, I believe that no damages will result to landowners by the regulating of this drain.

FINDINGS AND ORDER FOR RECONSTRUCTION

The matter of the proposed Reconstruction of the *Williams Creek Drain, Springmill Run Arm, Cedar Point Extension* came before the Hamilton County Drainage Board for hearing *on June 28, 2010*, on the Reconstruction Report consisting of the report and the Schedule of Damages and Assessments. The Board also received and considered the written objection of an owner of certain lands affected by the proposed Reconstruction, said owner being:

Evidence was heard on the Reconstruction Report and on the aforementioned objections.

The Board, having considered the evidence and objections, and, upon motion duly made, seconded and unanimously carried, did find and determine that the costs, damages and expenses of the proposed Reconstruction will be less than the benefits accruing to the owners of all land benefited by the Reconstruction.

The Board having considered the evidence and objections, upon motion duly made, seconded and unanimously carried, did adopt the Schedule of Assessments as proposed, subject to amendment after inspection of the subject drain as it relates to the lands of any owners which may have been erroneously included or omitted from the Schedule of Assessments.


The Board further finds that it has jurisdiction of these proceedings and that all required notices have been duly given or published as required by law.
