Re: Stultz and Almond Drain, 141st Street and Towne Road – Roundabout

Attached are petition, plans, and other information for the proposed reconstruction of the Stultz and Almond Drain, for the 141st Street and Towne Road Roundabout project. The reconstruction was petitioned by the City of Carmel. During this reconstruction, the Stultz and Almond Drain – Lakeside Park Section 5 Arm will be affected. Those changes are as follows:

**Stultz and Almond Drain**

Stultz and Almond Drain – Lakeside Park Section 5 Arm: The project will remove 210 feet of 6” SSD to the east and south of structure labeled as 105 per the plans for Lakeside Park Section 5, prepared by Stoepelwerth & Associates, having Job Number 41760S5, and date of 9/1/06. Also, the structure labeled as number 408 per the road plans, which is on the main Stultz and Almond Drain, will be changed from an inlet casting to a solid manhole casting and adjusted to match the pavement grade. This is shown on Sheets 19 and 20 of the plans prepared by American Structurepoint, Inc., having City of Carmel Project Number 06-12, and dated April 16, 2008.

The road project will remove 210 feet of the Stultz & Almond Drain, Lakeside Park Section 5 Arm.

The cost of the reconstruction is to be paid by the City of Carmel. Because the project is to be paid by the petitioner and is being completed within the right of way owned by the City of Carmel, the project falls under the requirements as set out in IC 36-9-27-52.5. Therefore, a hearing with 30 day notice is not required for the petition.

I recommend the Board approve the project at this time.

\_\_\_\_\_ The City of Carmel \_\_\_\_\_ (hereinafter "Petitioner").

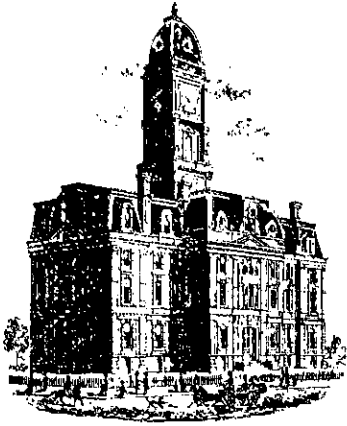
hereby petitions the Hamilton County Drainage Board for authority to relocate and improve a section of the \_\_\_\_\_ Stutz & Almond-Lincolnshire Arm \_\_\_\_\_ Drain, and in support of said petition advises the Board that:

1. Petitioner owns real estate through which a portion of the \_\_\_\_\_ Stutz & Almond \_\_\_\_\_ Drain runs.
2. Petitioner plans to develop its real estate with roads, buildings, utilities, storm drains, sanitary sewers and other structures.
3. Petitioner's proposed development of its real estate will require relocation and reconstruction of a portion of the \_\_\_\_\_ Stutz & Almond-Lincolnshire Arm \_\_\_\_\_ Drain, as specifically shown on engineering plans and specifications filed with the Hamilton County Surveyor.
4. The work necessary for the proposed relocation and reconstruction will be undertaken at the sole expense of the Petitioner and such work will result in substantial improvement to the \_\_\_\_\_ Stutz & Almond-Lincolnshire Arm \_\_\_\_\_ Drain, without cost to other property owners on the watershed of the \_\_\_\_\_ Stutz & Almond-Lincolnshire Arm \_\_\_\_\_ Drain.
5. Proposed relocation and reconstruction will not adversely affect other land owners within the drainage shed.
6. Petitioner requests approval of the proposed relocation and reconstruction under IC 36-9-27-52.5.

WHEREFORE, Petitioner requests that an Order issued from the Hamilton County Drainage Board authorizing relocation and reconstruction of the \_\_\_\_\_ Stutz & Almond-Lincolnshire Arm \_\_\_\_\_ Drain, in conformance with applicable law and plans and specifications on file with the Hamilton County Surveyor.


**Re: Stultz & Almond Drain: 141<sup>st</sup> St & Towne Rd Roundabout**

Attached are as-builts, certificate of completion & compliance, and other information for 141<sup>st</sup> St & Towne Rd Roundabout. An inspection of the drainage facilities for this section has been made and the facilities were found to be complete and acceptable.

During construction, changes were made to the drain, which will alter the plans submitted with my report for this drain-dated August 27, 2008. The report was approved by the Board at the hearing held September 8, 2008. (See Drainage Board Minutes Book 11, Pages304-305)  
The changes are as follows:  
There was a removal of 400 feet of 6" SSD.  
The length of the drain removed due to the changes described above is now **400 feet**.

I recommend the Board approve the drain's construction as complete and acceptable.
