Attached is a petition and plans for the proposed relocation of the Elwood Wilson Drain. The relocation is being proposed by Home Depot USA, Inc. The proposal is to realign the existing open ditch and tile arm between S.R. 32 and the east property line of the Home Depot property.

This line will consist of the following:

726' open ditch 184' 12x16 box 119' 24" RCP 56' 12x 5 box 25' 21" RCP 24' 4x15 box

The total length of the new drain shall be 1,134 feet. The 850 feet of original open drain and 270 feet of drain known as the new arm between S.R. 32 and the east property line of the Home Depot tract shall be vacated. This proposal will add an additional 14 feet to the drains total length.









WATERSHED AREA




