Re: Jacob Yansel Drain

At this time it has come to the attention of this office that several property owners within the upper drainage shed of the Jacob Yansel Drain wish to subdivide their parcels. This was reported to the Board at its meeting on April 9, 2007 (Drainage Board Minutes Book 10, Pages 202 to 203).

Upon review and inspection of this drain it has been determined that the drain is inadequate to handle the drainage from any additional impervious surfaces or connections and is in need of reconstruction. Therefore, this office shall deny any request for connections until the drain is reconstructed per IC36-9-27-17d.

This determination affects the following tracts within the Yansel Drainage Shed:

Notice is hereby given that the Hamilton County Drainage Board will hold a public hearing on the 29<sup>th</sup> day of May, 2007, at 9:45 a.m. to consider a report of the County Surveyor to prohibit further connections to the Upper Drainage Shed of the Jacob Yansel Drain until the drain is reconstructed. The report and a list of the affected parcels are available for public inspection in the office of the County Surveyor. The report finds that the designated part of the drain is not adequate to handle any additional flow without being reconstructed and recommends the denial of any requests for further connections to the drain until reconstruction.

Any landowner affected by the report may appear at the hearing and may address the Board in person or in writing. After the hearing, the Board may adopt, amend, or reject the report. If the report is adopted, any use on the affected parcels which increases runoff into the drain, will be denied until the drain is reconstructed. A copy of the Board's written action will be recorded. The Board reserves the right to continue the Public Hearing and/or its ruling on the report.

### RESOLUTION NO. DB-05-29-07-A

## A RESOLUTION OF THE HAMILTON COUNTY DRAINAGE BOARD CONCERNING THE JACOB YANSEL DRAIN

#### WITNESS THAT:

WHEREAS, the Hamilton County Drainage Board has jurisdiction to regulate the discharge of storm water from certain parcels of real estate which directly or indirectly discharge into the Jacob Yansel Drain ("the Drain"); and,

WHEREAS, the Hamilton County Surveyor has been advised that owners of certain parcels within part of the drainage shed served by the Drain, are interested in developing said parcels; and,

WHEREAS, the development of the parcels within part of the upper part of the drainage shed served by the Drain will create additional impervious surface which will result in additional storm water being discharged into the Drain; and,

WHEREAS, the Hamilton County Surveyor, pursuant to the authority granted by Indiana Code 36-9-27-17(d) has investigated the condition of the Drain as it serves the affected watershed ("the Watershed"); and,

WHEREAS, the Hamilton County Surveyor has investigated the capacity of the portion of the Drain serving the Watershed and has filed his Report of May 3, 2007, ("the Report") a copy of which is attached hereto; and,

WHEREAS, the Report further includes a finding that the Drain is inadequate to handle additional flow of water resulting from connections without being reconstructed and recommends that no further connections to the Drain be permitted until the Drain is reconstructed under Indiana Code 36-9-27-49 through Indiana Code 36-9-27-17; and,

WHEREAS, a Notice of Public Hearing to consider the Report was duly published at least ten (10) days in advance of the public hearing held on May 29, 2007, and the property owners within the Watershed have been mailed the Notice of the Public Hearing; and,

WHEREAS, the Drainage Board has held a public hearing on May 29, 2007, and considered all evidence presented at the public hearing, including the Report.

IT IS THEREBY RESOLVED by the Hamilton County Drainage Board as follows:

- The Hamilton County Drainage Board hereby ratifies and approves the Report of the Hamilton County Surveyor of May 3, 2007.
- 2. The Hamilton County Drainage Board will not permit any additional connections, to discharge directly or indirectly into the Jacob Yansel Drain, from the above parcels of real estate, or any parcels resulting from splits of the above parcels, unless or until the Drain is reconstructed.
- 3. The Hamilton County Surveyor shall cause a copy of this Resolution to be recorded in the Office of the Hamilton County Recorder, and this Resolution shall be cross referenced to the last Deed of record of all of the property owners listed above.

4. The Hamilton County Drainage Board reserves unto itself the right to amend or modify this Resolution upon petition from any property owner within the Watershed.
