Re: Cool Creek Drain, P.L. Porter Arm, U.S. 31 Reconstruction - East Street

Attached are petition, plans, and other information for the proposed reconstruction of the P.L. Porter Arm of the Cool Creek Drain, for East Street, which is part of the U.S. 31 Road Project. The reconstruction was petitioned by the Indiana Department of Transportation. During the road reconstruction, the Cool Creek Drain, P.L. Porter Arm will be affected and those changes are as follows:

P.L. Porter Arm

The project will reconstruct a portion of open ditch which is part of the P.L. Porter Arm. The existing pipe end section, which is Str. 601 per the construction plans for P.L. Porter Company by Paul I. Cripe, having job number 89463-00000, and dated March 15, 1990, shall be removed. The existing open ditch will be enclosed with 71 feet of 30" RCP and the end section replaced on the new end of the pipe. This is as shown on sheets 55 and 93 of the U.S. 31 Construction plans having project number 1296427, contract number IR-34750, and dated August 10, 2012. The total length of new drain shall be 71 feet. The 71 feet of original open ditch shall be vacated.

This proposed reconstruction will result in no change to the total length of the P.L. Porter Arm.

The cost of the reconstruction is to be paid by the Indiana Department of Transportation.

Since the petitioner is the Indiana Department of Transportation and is being performed under public bid process, no bond is required for the relocation/reconstruction work.

The easement for this drain shall remain the existing statutory 75' from the centerline of the tile or the top of bank of the open ditch, as per IC 36-9-27-33. This reconstruction of the regulated drain will not change or relocate the easement. Work will be completed in the easement of the following parcels:

On this 22nd day of April, 2013, the Hamilton County Drainage Board has held a hearing on the Maintenance Report and Schedule of Assessments of the Cool Creek Drain, P. L. Porter Arm, U.S. 31 Reconstruction - East Street, 71' of Original Open Ditch.

Evidence has been heard. Objections were presented and considered. The Board then adopted an order of action. The Board now finds that the costs of continued maintenance to the portion of the above drain exceed the benefits to the real estate benefited by the portion of the drain to be abandoned and issues this order vacating the above section of the Cool Creek Drain, P. L. Porter Arm, U.S. 31 Reconstruction - East Street, 71' of Original Open Ditch.

FINDINGS AND ORDER FOR RECONSTRUCTION

The matter of the proposed Reconstruction of the *Cool Creek*Drain, P. L. Porter Arm, U.S. 31 Reconstruction - East Street came before the Hamilton County Drainage Board for hearing on April 22, 2013, on the Reconstruction Report consisting of the report and the Schedule of Damages and Assessments. The Board also received and considered the written objection of an owner of certain lands affected by the proposed Reconstruction, said owner being:

Evidence was heard on the Reconstruction Report and on the aforementioned objections.

The Board, having considered the evidence and objections, and, upon motion duly made, seconded and unanimously carried, did find and determine that the costs, damages and expenses of the proposed Reconstruction will be less than the benefits accruing to the owners of all land benefited by the Reconstruction.

The Board having considered the evidence and objections, upon motion duly made, seconded and unanimously carried, did adopt the Schedule of Assessments as proposed, subject to amendment after inspection of the subject drain as it relates to the lands of any owners which may have been erroneously included or omitted from the Schedule of Assessments.

The Board further finds that it has jurisdiction of these proceedings and that all required notices have been duly given or published as required by law.

Wherefore, it is ORDERED, that the proposed Reconstruction of the Cool Creek Drain, P. L. Porter Arm, U.S. 31 Reconstruction - East Street be and is hereby declared established.

Thereafter, the Board made inspection for the purpose of determining whether or not the lands of any owners had been erroneously included or excluded from the Schedule of Assessments. The Board finds on the basis of the reports and findings at this hearing as follows:

Re: Cool Creek Drain: P.L. Porter Arm, US 31 Reconstruction - East Street

Attached are as-builts and other information for US 31 Reconstruction – East Street. An inspection of the drainage facilities for this section has been made and the facilities were found to be complete and acceptable.

During construction, changes were made to the drain, which will alter the plans submitted with my report for this drain-dated February 1, 2013. The report was approved by the Board at the hearing held April 22, 2013. (See Drainage Board Minutes Book 14, Pages 552-554) The changes are as follows: the project enclosed 72 feet of existing open ditch with 72 feet of 30" RCP. The length of the drain due to the changes described above is now **72 feet**.

The project was done within existing regulated drain easement and road right of way. The cost of the project was paid for by Indiana Department of Transportation.


I recommend the Board approve the drain's construction as complete and acceptable.


