Re: Mary Johnson Drain: Elbrecht-Freedom Ready Mix Reconstruction

After review, it should be noted that the Elbrecht-Freedom Ready Mix Reconstruction has been withdrawn from being constructed at this time. The report for the project was approved by the Board at the hearing held May 29, 2007. (See Drainage Board Minutes Book 10, Pages 261-268) The proposal was to replace 2,864 feet of existing tile with 2,552 feet of 18", 21", 24', and 36" HDPE.

Once the project is once again submitted by the developer, the project will then be rereviewed and brought before the board for re-consideration. At, this time a capital asset form is being submitted to remove the project from the GASB 34 inventory.

I recommend the Board at this time accept the request to have the project withdrawn and approve the attached Capital Asset Disposal Form.

Re: Mary Johnson Drain Reconstruction

Attached is a petition and plans for the proposed reconstruction of the Mary Johnson Drain. The reconstruction is being proposed by Elbrecht - Freedom Ready Mix. The plans for the Freedom Ready Mix project by DeBoy Land Development Services, Project No. 2006-0023, dated 7/21/2006, will reconstruct the regulated drain from station 18 of Arm 2 to the Mary Johnson Drain originally constructed in 1908, which is Station 25+52 on the DeBoy plan, to station 35+84 of Arm 2 to the Mary Johnson Drain which is also station 32+02 of the Mary Johnson Main Drain and which is shown as Station 8+00 on the DeBoy plan, to the outlet at Station 42+82 of the Mary Johnson Main Drain which is shown as station 0+00 on the DeBoy plan.

This line will consist of the following:

741' of 36" HDPE Pipe 62' of 36" RCP 946' of 24" HDPE Pipe 401' of 21" HDPE Pipe 402' of 18" HDPE Pipe

The length of the drain to be reconstructed is 2,552 feet which will replace 2,864 feet which is a net reduction in length of 312 feet as calculated from stationing on the original plans.

The cost of the reconstruction is to be paid by Elbrecht - Freedom Ready Mix. The engineers estimate for the reconstruction is \$270,000.00. A performance bond for 120% of the engineers' estimate will be provided by the developer in the amount of \$324,000.00 within 30 days of the reconstruction hearing and prior to reconstruction.

The proposal will reconstruct the drain across the following parcels:

The reconstruction will be completed in the existing regulated drain easement as set out in I.C. 36-9-27-33. Therefore no damages will result and all damages shall be set at \$0.00.

This reconstruction proposal includes a resolution for reimbursement to Elbrecht -Freedom Ready Mix which will address assessments for parcels that will develop in the future which will reimburse Elbrecht - Freedom Ready Mix for the cost of reconstructing the Freedom Arm of the Mary Johnson Drain. The referenced resolution includes the attached exhibits "A", "B" and "C".

I recommend that the Board set a hearing date for May 29, 2007.

FINDINGS AND ORDER FOR RECONSTRUCTION

The matter of the proposed Reconstruction of the **Mary Johnson Drain** came before the Hamilton County Drainage Board for hearing **on May 29, 2007,** on the Reconstruction Report consisting of the report and the Schedule of Damages and Assessments. The Board also received and considered the written objection of an owner of certain lands affected by the proposed Reconstruction, said owner being:

Evidence was heard on the Reconstruction Report and on the aforementioned objections.

The Board, having considered the evidence and objections, and, upon motion duly made, seconded and unanimously carried, did find and determine that the costs, damages and expenses of the proposed Reconstruction will be less than the benefits accruing to the owners of all land benefited by the Reconstruction.

The Board having considered the evidence and objections, upon motion duly made, seconded and unanimously carried, did adopt the Schedule of Assessments as proposed, subject to amendment after inspection of the subject drain as it relates to the lands of any owners which may have been erroneously included or omitted from the Schedule of Assessments.

The Board further finds that it has jurisdiction of these proceedings and that all required notices have been duly given or published as required by law.

Wherefore, it is ORDERED, that the proposed Reconstruction of the Mary Johnson Drain be and is hereby declared established.

Thereafter, the Board made inspection for the purpose of determining whether or not the lands of any owners had been erroneously included or excluded from the Schedule of Assessments. The Board finds on the basis of the reports and findings at this hearing as follows:

RESOLUTION DB 5-29-09-C

A RESOLUTION OF THE COUNTY DRAINAGE BOARD RECLASSIFYING THE MARY JOHNSON DRAIN AND ESTABLISHING DRAINAGE ASSESSMENTS FOR RECONSTRUCTION OF THE FREEDOM ARM

WHEREAS, there is presently a regulated drain located in Adams Township, Hamilton County, Indiana, referred to as the "Mary Johnson Regulated Drain" (the "Drain");

WHEREAS, it is in the best interest of the health, safety, and welfare of the citizens of Hamilton County, and certain landowners within the County, that a certain section of the Drain be reconstructed and reclassified as an urban drain in accordance with Indiana Code 36-9-27-69;

WHEREAS, said section of the Drain should be known as the "Freedom Arm" of the Drain (the "Freedom Arm");

WHEREAS, certain parcels of land within the Drain's watershed will be benefited (the "Benefited Parcels") by the reconstruction of the Freedom Arm (the "Reconstruction");

WHEREAS, the Hamilton County Surveyor has completed a report (the "Report") that contains a mathematical calculation as to the assessment for the reconstruction of the Freedom Arm;

WHEREAS, the Benefited Parcels currently consist of rural areas that are drained adequately without the Reconstruction and, therefore, there should be no assessment imposed upon the Benefited Parcels at the present time as provided by Indiana Code 36-9-27-69 (b) (6); and

WHEREAS, a public hearing was held on the 29^{4} day of 300, 500, for the Reconstruction;

IT IS THEREBY RESOLVED by the Hamilton County Drainage Board as follows:

- 1. The Drain is hereby reclassified as an urban drain in accordance with Indiana Code 36-9-27-69.
- 2. There is hereby established the Freedom Arm, identified in Exhibit A attached hereto.
- 3. The Benefited Parcels include property within the Drain's watershed, generally located north of 216th Street and west of U.S. Highway 31 North, and are represented more specifically by the areas identified as "Upper

Parcels" (the "Upper Parcels") and "Lower Parcels" (the "Lower Parcels") in Exhibit B attached hereto.

- 4. The Report attached hereto as Exhibit C is hereby ratified and approved. The Report identifies costs of the Reconstruction totaling Two Hundred and Seventy Thousand Dollars (\$270,000.00). The Report establishes the formula and total assessment for each of the Benefited Parcels. The assessments equal the value of benefits conferred upon such parcels.
- 5. There is no assessment imposed upon the non-urban portion of the drain at this time. The assessment for the current non-urban parcels shall be assessed and collected when those parcels are developed, redeveloped or platted for development, whichever occurs first.
- 6. Assessments made against the Benefited Parcels under the terms of this resolution shall be assigned to Freedom Ready Mix, LLC or its assigns as reimbursement for construction of the existing drain. This assignment shall be the total payment to Freedom Ready Mix, LLC for the dedication of the reconstructed Freedom Arm.




