Re: 2022 Reconstruction of the LN Joseph and Eli Brooks Arm of the William Lehr Drain

Attached are a petition, Construction Drawings, drain map, drainage-shed map, and schedule of assessments for the reconstruction of the LN Joseph and Eli Brooks Arm (dating to 1893) and the LN Joseph Arm (dating to 1952) of the William Lehr Drain.

The LN Joseph and Eli Brooks Arm and the LN Joseph Arm are located in Noblesville Township of Hamilton County and benefits properties in Sections 9 and 16 of Township 18 North, Range 5 East.

The proposed project will improve the flow characteristics of the drain, and is the last phase of a multiphased project to reconstruct the drain.

I have made a personal inspection of the land described in the petition. Upon doing so, I believe that the drain is practicable, will improve the public health, benefit a public highway and be of public utility; and that the costs, damages and expenses of the proposed drain will probably be less than the benefits accruing to the owners of land likely to be benefited.

History:

The Eli Brooks Drain was established in 1893 (See Reviewers Report, December 7, 1893). The LN Joseph Drain was established in 1908 (See Surveyor Report, August 25, 1908). The 1908 report describes the LN Joseph Drain as "following in the old channel of what is known as the Eli Brooks ditch..." Per a November 17, 1952 viewers report for the reconstruction of the LN Joseph Drain, "the LN Joseph ditch was formerly part of, by the record, of the Eli Brooks ditch and when tiled was given the name of the LN Joseph Ditch."

The Eli Brooks and LN Joseph Drain tiles were reconstructed through the Circuit Court in 1952/3.

The LN Joseph and Eli Brooks Drains were combined with the William Lehr Drain and the Booth-White Drain in 1967 when the drains were placed on the maintenance program which was approved at hearing on December 4, 1967 under the then fairly new 1965 Indiana Drainage Code. (See Hamilton County Drainage Board Minutes Book 1, Page 23). The Drains remain on this maintenance program.

A Surveyors report dated December 8, 2005 was presented to the Board at the December 22, 2005 meeting of the Drainage Board. The report indicated that 2,846-feet of the LN Joseph and Eli Brooks Arm of the William Lehr Drain was to be relocated and reconstructed between Stations 21+48 and 49+94 as part of the Waterman Farms Development. The total length of the new drain was indicated to be 3,998-feet, adding 1,152-feet to the length of the Drain. The reconstruction and relocation was approved at hearing during this meeting. (See Hamilton County Drainage Board Minutes Book 8, Pages 568-569).

A Surveyor's report dated October 16, 2007 was presented to the Board at the January 28, 2008 meeting of the Drainage Board. The report indicated that 38-feet of the LN Joseph and Eli Brooks Drain would be vacated between Stations 0+00 and 0+38. The vacation was approved at hearing during this meeting. (See Hamilton County Drainage Board Minutes Book 11, Pages 12-13).

A Surveyor's Report dated August 5, 2015 was presented to the Board at the September 28, 2015 meeting of the Drainage Board. The report outlines that as part of the Noble East and Flagstone subdivision, the LN Joseph and Eli Brooks Drain would be relocated and reconstructed and consist of 3100-feet of open drain, 110-feet of 8x4 box culvert, and 147-feet of 18" RCP with a total length of 3,357-feet. The existing 2,936-feet between stations 92+19 and 121+55 will be abandoned. This reconstruction was approved after the public hearing during this meeting. (See Hamilton County Drainage Board Minutes Book 16, Pages 306-307).

A public hearing was held at the November 28, 2016 meeting of the Drainage Board. A Surveyor's Report dated September 21, 2016 was presented that outlined that Fiore Nursery was proposing to reconstruct the LN Joseph and Eli Brooks Drain between Stations 49+94 and 60+45. The reconstructed drain would consist of 840-feet of open ditch and 206-feet of 24" RCP with a total length of 1,066-feet. The existing tile (installed in 1893) between Stations 49+94 and 60+45, a length of 1,051-feet, would be removed and abandoned. The report notes that an existing 16" regulated drain tile in the vicinity, being part of the LN Joseph Arm installed in 1952, would remain intact. The tile was indicated in the report to be located east of the parcel line with Hoods Gardens (parcels 10-11-16-00-00-14.000 and 10-11-16-00-00-010.001) and generally running parallel with the proposed reconstruction. Where the tile parallels the reconstruction, the tile is 1,014-feet of 16" tile between Stations 60+45 and 70+59 and was to remain in place to provide for drainage of any remaining private tiles east of the reconstruction area. The project was approved after the public hearing during the meeting. (See Hamilton County Drainage Board Minutes Book 17, Pages 204-206).

At the May 2019 meeting of the Drainage Board, a public hearing was held for the partial vacation of the LN Joseph Arm. A Surveyor's Report dated April 5, 2019 was presented. The report outlines that the vacation of the segment of the LN Joseph Arm on Parcel 10-11-16-00-00-010.000 between Stations 60+45 and 70+59, a length of 1,014-feet. The drain is listed as generally being located on the west parcel line of Parcel 10-11-16-00-00-010.001. The vacation was approved after the public hearing during this meeting. (See Hamilton County Drainage Board Minutes Book 18, Pages 449-450).

At the December 19, 2019 meeting of the Drainage Board, a public hearing was held for the Campus Center Relocation of the LN Joseph and Eli Brooks Arm of the William Lehr Drain. A Surveyor's Report dates November 1, 2019 was presented. The reconstructed drain would consist of 797-feet of 24" RCP. 1,010-feet of the existing tile between Stations 3+25 and 13+35 would be vacated. The report notes that the existing 10" tile between Stations 13+35 and 21+48 would remain. The reconstruction was approved after the public hearing during this meeting. (See Hamilton County Drainage Board Minutes Book 19, Pages 83-86).

Also at the December 19, 2019 meeting of the Drainage Board, a 52.5 Hearing was held for the William Lehr, LN Joseph and Eli Brooks Arm and LN Joseph Arm – Brooks Farm Section 1 Reconstruction. A Surveyor's Report dated December 4, 2019 was presented. The reconstruction would consist of 2,095-feet of open drain and 113-feet of 6'x8' Box Culvert and consist of 2,208-feet of drain between Stations 68+30 and 89+05. Station 68+30 is at the north right-of-way line of 156th Street and Station 89+05 is where the arm connects to Manhole 710 installed with the 2015 Noble East and Flagstone relocation. The existing tile between Stations 68+30 and 89+05 would be 68+30 and 89+05, a length of 2,075-feet, would be removed and vacated. The report notes that the LN Joseph Arm runs parallel with the LN Joseph and Eli Brooks Arm or much of the site before merging at a box structure. The existing 1,518-feet of the existing LN Joseph tile between existing Stations 78+51 and 93+69 would be removed and vacated. Station 78+51 is located at the proposed north right-of-way line of 156th Street. Station 93+69 is the existing point of confluence, a catch basin at Station 83+55 of the LN Joseph and Eli Brooks Arm. The reconstruction was approved after the hearing during this meeting. (See Hamilton County Drainage Board Minutes Book 19, Pages 86-88).

Current Condition of the Drain:

The Drains function but are undersized by today's standards. The Drains are between 70 and 129-years old and have exceeded the expected service life of such tiles. Routine maintenance is required for the Drains to function.

Based on a search of the County's database for drainage complaints, there have been six (6) Drainage Complaints logged in to the County's database for such complaints since 2014. The complaints are listed below.

Proposed Project:

The proposed project will reconstruct the Drains between Stations 60+45 and 68+30. The project will include 1,002-feet of new open ditch drain; 92-LF of 5'x8' precast box culvert under 156th Street with end sections; 1 type "E" precast inlet with casting; 20-foot 4'x8' precast box culvert field crossing with end sections; demolition and clearing; pavement removal and repair where the drain crosses 156th Street; pavement markings; #2 stone farm crossing; maintenance of traffic; construction phase erosion and sediment control; riprap loose; rip-rap in gabion baskets; rock check dam; 40-foot tile drain extension; 2-surface water pipes; erosion control blanket; and seeding of the grass waterway and disturbed non-farmed areas.

The existing LN Joseph and Eli Brooks Drain and the LN Joseph Drain within the limits of the project will either be removed by the construction or abandoned in place.

This is the last phase of a multiphase project that reconstructed the majority of the LN Joseph and Eli Brooks Drain. Starting in 2005, the Drain will have been reconstructed between Stations 21+48 and 121+55.

After this project is complete, 813-feet (between Stations 13+35 and 21+48) of the original LN Joseph and Eli Brooks Drain will remain in service

Easements

The proposed project will take place within existing regulated drainage easements.

The statutory easement over the existing LN Joseph and Eli Brooks Drain will be shifted between Stations 60+45 and 68+30 to follow the new open ditch. Between these stations, the existing tile will be removed or abandoned in place. The shifted easement will encompass the area between the tops-of-bank of the new open ditch and an area 35-feet in width measured perpendicularly from the eastern top-of-bank of the new open ditch. The easement will be shifted on parcel 10-11-16-00-00-009.000 currently owned by S&T Land Holdings, LLC.

Permits

As this project is constructing a new open ditch, no permits are required from the IDNR, IDEM, or the U.S. Army Corps of Engineers.

Changes to the Drain

The existing LN Joseph and Eli Brooks Drain between Stations 60+45 and 68+30, a length of 785-feet will be abandoned in-place. The new open drain will be 1,114-feet in length. The project will add 329-feet to the LN Joseph and Eli Brooks Drain.

The LN Joseph Drain will be abandoned in place between Stations 70+59 and 78+51 and the LN Joseph Drain will be reduced in length by 792-feet.

Construction Cost:

Two bids were received: Morphey Construction in the amount of \$624,000.00 and Hoosier Pride Excavating in the amount of \$750,814.05. The lowest bidder was Morphey Construction. Based on the bid received, the cost of construction for this project is outlined below.

Total Project Costs

The total cost of the project includes construction costs, contingency costs, and professional service costs. The total cost of this project is \$817,600.00. The various costs are outlined below:

Project Funding:

The cost of the work within the rights-of-way of 156th Street, shall be paid by the City of Noblesville per IC 36-9-27-71. Line Items 6, 8, 9, 11, 12, 16, 18 (for 2 of the 4 toe walls), 19, and 20 are costs associated with the roadway crossings and have a value of \$259,016 from the Morphey Bid. With a 15% contingency, the lump sum cost to be assessed to the City of Noblesville will be \$297,868.40.

The balance of the total cost of the project may be funded by the Coronavirus State and Federal Fiscal Recovery Funds of the American Rescue Plan. The construction estimate submitted for ARP funding by the Surveyor for the reconstruction project was \$498,000.00. At this time, these funds have not been approved. Therefore, the \$519,731.60 has been spread evenly across the drainage shed at a rate of \$1,015.79 per acre. If the ARP funding is approved, the cost to be spread across the drainage shed would be reduced to \$21,731.60.

The final project costs shall be based on the actual construction contract amounts, professional services contract amounts, and any approved change orders.

I believe that no damages will result to landowners by reconstruction of this drain. Therefore, damages shall be set at \$0.00.

I recommend the Board set a hearing for this reconstruction for November 28, 2022.


