Attached are as-builts, and other information for Loma Industrial Park II Drain. An inspection of the drainage facilities for this section has been made and the facilities were found to be complete and acceptable.

During construction, changes were made to the drain which will alter the plans submitted with my report for this drain dated November 12, 1985. The changes are as follows:

- >145 feet of six (6") inch CMP not used-this was replaced by twelve (12") inch CMP under Loma Court.
- Use Length of six (6") inch tile was increased from 650 feet to 850 feet

Revised lengths are as follows: 6 - 6" CMP 40 feet (Metal tile outlets at end of 6" tile runs) 1 N. 6" Tile 850 feet (along front of Lots 508 and from retention pond to Lots 10 & 11) 72" X 44" CMPA 58 feet (under Loma Court) 1.1 U_{0} 24" CMP 30 feet (as outlet of retention pond) 12" CMP 215 feet (under Loma Court between Lots 2 & 15, 335 -Lots 4 & 14 and Lots 1 & 16 along East R/W of Hague Road) 1530 - Open Ditch 1530 feet (includes swale from Loma Court to open ditch along West and South sides of Lot 1)



Attached is a petition, non-enforcement request, plans, calculations, cost estimate and assessment roll, for the LOMA INDUSTRIAL PARK II DRAIN.

I have reviewed the submittals and petition and have found each to be in proper form.

I have made a personal inspection of the land described in the petition. Upon doing so, I believe that the drain is practicable; will improve the public health; benefit a public highway and be of public utility; and that the costs, damages and expenses of the proposed drain will probably be less than the benefits accuruing to the owners of land likely to be benefitted. The drain will consist of the following:

145	feet	6" CMP
650	feet	6" Tile
58	feet	72" x 44" CMPA
30	feet	24" CMP
1150	feet	Open Ditch

The total length of the drain will be 2033 feet.

I have reviewed the plans and believe the drain will benefit each lot equally. Therefore, I recommend each lot be assessed equally. I recommend a maintenance assessment of \$40.00 per lot, \$2.00 per acre for roadways. With this assessment the total annual assessment for the draining section will be \$696.50.

I recommend a hearing be set for January 13, 1986.

The drainage will affect various lots in <u>Loma</u> <u>INDUSTRIAL PARIX II</u>, a subdivision in Hamilton County, Indiana. The general route of such drainage shall be in existing easements and along public roads as shown in the plans on file in the Surveyor's Office.

Petitioner believes that the cost, damages and expenses of the proposed improvement will be less than the benefits which will result to the owners of the land likely to be benefited thereby. Petitioner believes the proposed improvement will: .

- (a) improve public health
- (b) benefit a public street
- (c) be of public utility

Petitioner agrees to pay the cost of construction of the drainage system and requests periodic maintenance assessments by the Board thereafter. The Petitioner also agrees to the following:

 To provide the Drainage Board a Performance Bond for the portion of the drainage system which will be made a regulated drain. The bond will be in the amount of 100% of the Engineers estimate. The bond will be in effect until construction of 100% of the system is completed and so certified by the Engineer.

- 2. The Petitioner shall retain the Engineer throughout the construction phase. At completion of the project the Petitioners Engineer shall certify that the drainage system which is to be maintained as a regulated drain has been constructed as per construction plans.
- 3. The Petitioner shall request all changes from the approved plan prior to implementation of the change. All changes shall be documented and given to the Surveyor to be placed in the Drain file.
- 4. The Petitioner shall instruct his Engineer to provide a a reproducable print on a 24" x 36" mylar of the final design of the Drainage System. This shall be submitted prior to the release of the Performance Bond.
- 5. The Petitioner shall comply with the Erosion Control Plan as specified on the construction plans. Failure to comply with the Erosion Control Plan shall be determined by the Board as being an obstruction to the drainage system. The Surveyor shall immediately install or repair the needed measures as per IC 36-9-27-46.

The Petitioner further requests that the Drain be classified as an Urban Drain.






