

Re: Stony Creek Drainage Area, Maintenance Rate Increase

The residential & agricultural maintenance rates for the Stony Creek Drainage Area were increased from \$2 per acre to \$4 per acre per my report to the Board dated April 6, 2010 and approved on July 26, 2010 as part of the Locke Arm reconstruction. There were nine (9) residential/agricultural parcels below S.R. 32 that were not part of the Locke Arm reconstruction and therefore did not receive notification of the increase in the maintenance rate. The current rate brings in \$550.60 annually for the nine parcels. The revised total assessment for the nine parcels will be \$1,076.20 annually. I recommend the Board set November 22, 2010 for this proposal.

FINDINGS AND ORDER


CONCERNING THE MAINTENANCE OF THE


