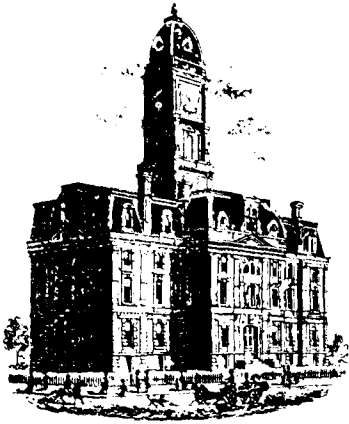

Re: Elliott Creek Drain, Roller, Linnemeier Extension

Attached is a drain map, drainage shed map and schedule of assessments for the extension of the Elliott Creek Drain. This proposed drain is located in Clay Township.

I have made a personal inspection of the land described below. Upon doing so, I believe that the drain is practicable, will improve the public health, benefit a public highway and be of public utility and that the costs, damages and expenses of the proposed drain will probably be less than the benefits accruing to the owners of land likely to be benefited. The drain will consist of the following:

Open Ditch 1,068 ft.

The total length of the drain will be 1,068 feet.

The extension will begin at the east line of tract 17-09-28-00-00-027.000. This is the terminus of the drain per my report dated June 10, 1999 and approved by the Board at hearing on July 26, 1999. (See Hamilton County Drainage Board Minute Book 5, Pages 188 & 189). The extension will follow the existing open ditch to the south line of tract 17-09-27-00-00-034.000.

The current rates for the Elliott Creek Drain are \$3.00 per acre with a \$15.00 minimum. Roads are assessed at \$10.00 per acre. The annual maintenance collection for this extension will be \$101.72.


I believe this proposed drain meets the requirements for Urban Drain Classification as set out in IC 36-9-27-67 to 69. Therefore, this drain shall be designated as an Urban Drain.

The easements for the drain should be set at 75' from top of bank as set out in IC 36-9-27-33. Additional drainage easement will be added to the following tracts:



FINDINGS AND ORDER FOR RECONSTRUCTION

The Board, having considered the evidence and objections, and, upon motion duly made, seconded and unanimously carried, did find and determine that the costs, damages and expenses of the proposed Reconstruction will be less than the benefits accruing to the owners of all land benefited by the Reconstruction.



The Board further finds that it has jurisdiction of these proceedings and that all required notices have been duly given or published as required by law.




