Attached is a petition to reconstruct the Asher Drain along with plans for the proposal filed by One Eleven Associates LTD. The proposed reconstruction is a relocation of the drain which will permit the construction of the PIA Hospital. The proposal calls for the interception of the drain at STA 26+85 which is on the north side of 111th Street. The portion of the drain from STA 27+15 to STA 32+65 (Point drain crosses onto Delta Faucet) will be abandoned. The drain in this section will be replaced with 24", 36", 42" RCP. The portion of the existing drain under 111th Street from STA 26+85 to 27+15 will be replaced with the 36" RCP.

The proposed drain as shown of the plan will begin at STR 101 and then run to STR 102, 103, 104, 105, 107, 109, 110, 112, and 113. The roundabout installed at 111th and Pennsylvania was originally designed to relocate this arm. However, this did not happen and one new structure was set on this line. (See Final Report dated October 11, 2016.)

It should be noted that the project did remove three sections of drain on the PIA Hospital Arm to the Vernon Asher. The first section is Structures 108 to 107. This section was 55 feet of 12" RCP. The second section is Structures 111 to 110. This consisted of 35 feet of 15" RCP. The third section is Structures 106 to 105. This consisted of 50 feet of 12" RCP. These were originally installed to pick up roadside drainage but were no longer necessary as the intersection was improved and widened.
