**BACK TAX AND CIVIL PENALTIES** - Follow the instructions above, for Other Assessments and Liens, to retrieve details.

Your tax amount may include additional back taxes and civil penalties calculated due to an ineligible homestead pursuant to IC 6-1.1-12 37(f) for one of the following reasons: you claimed multiple standard homesteads, you failed to respond to a Residency Verification letter, or your property is not your principal residence.
